# Rev. Colonel John O. Woods

## Our Beloved Chaplain and Great Friend

### September 20, 1907-August 7, 2005

---

REV. COLONEL JOHN O. WOODS, U.S. Army 80th Infantry Division retired, 97 of St. Paul Homes, West Salem Township, died at 4:50 a.m. Sunday August 7, 2005 at UPMC Horizon, Greenville, PA. He was born September 20, 1907, in Laramie, Wyo., to the Rev. Oscar and Frederica (Prah) Wood.

A 1924 graduate of Elderton, PA, High School, he earned a Bachelor of Arts degree from Thiel College, Greenville, in 1928. In 1931, he earned a master of divinity degree from Chicago Lutheran Theological Seminary. Thiel College awarded him an honorary doctor of divinity degree.

Following his ordination, he served as [pastor of St. Paul's Evangelical Lutheran Church, Coudersport, PA., from 1931 to 1935. Throughout his retirement, he enjoyed serving as a supply pastor to congregations throughout the Northwestern Pennsylvania Synod.

In 1935, he was called to active duty as a Reserve Army chaplain, attached to the Civilian Conservation Corps in Virginia, where he served until 1939, when he was commissioned into the regular Army. In 1942, he joined the 80th Infantry Division, went to Europe with this outfit and remained with the 80th Infantry for 3 1/2 years.

During World War II he was awarded four battle stars, including the Battle of the Bulge in the winter of 1944.

His tours of duty included Fort Le, VA, Frankfort, Germany, Fort Meade, MD.; Korea, and Fort Knox, KY. From 1956 through 1962, he was XVIII Airborne Corps Chaplain with headquarters at Fort Bragg, NC.

A cross-country runner for most of his life, at the age of 49 he earned his parachutist wings, and also the Master Parachutist Badge. During this time, he made more than 90 military jumps from military aircraft.

From 1962 to 1966, he was stationed at Heidelberg, Germany, as senior Chaplain of the U.S. Army Europe. He was retired as a chaplain at the rank of Colonel in October 1967 by the U.S. Army at Valley Forge General Hospital, Phoenixville, PA.

His awards and Decorations include the Legion of Merit, the Bronze Star Medal and various campaign and theater medals and ribbons from WW II, Korea and Vietnam eras. He loved the military and people, no matter where he lived. He was especially fond of people of Greenville where he retired.

He was a member of Holy Trinity Lutheran Church, Greenville. He participated in many local organizations, including Kiwanis Club, American Legion Post 140, Cpl. James O. Jordan Veterans of Foreign Wars Post 3374, all of Greenville, PA. 80th Division Veterans Association, Greenville Ministerial Association, Thiel College Alumni Board, Penn Lakes Girl Scout Council, Korean Bible Society, Food Pantry and many others.

# LETTERS

---

1st Sgt. Frank Dobozy entered service at Fort Hayes, Ohio in 1937 and left in 1940. In February 1941, he entered as a Buck Sgt. 1st Mechanical Cavalry Armor Division. Four Campaign Stars ETO, Bronze Star and Oak Leaf. He also received Purple Heart at Kingman, Luxembourg.

He spent 1949-1953 in Germany, then was sent to Japan. He was also in Korea from 1954-55, under Sgt. Major Ardiane Sector. 10 years at Fort Knox, Kentucky, made Sgt. Major in charge of institution officer of investigated allotments.

1st Sgt. Orville Munyon was killed, and Jack Edwards was in back of him. Munyon received shrapnel in the back of his lung and Medic Tony Sterk and Jack Edwards helped him out. The Medic taped him up and the first thing Munyon asked for was a cigarette. The radio was not working. The 4th Weapon Platoon was there with Sgt. Hubert.

1st Sgt. Davison was captured at St. Avold and Sgt Dobozy then took over. Capt. Robert Smith was also wounded at Kingman, Luxembourg and 1st Sgt. Dobozy got a bullet through his helmet and received the Purple Heart. Dobozy had a 1903 Riffle with a Sniper Scope and 2 or 3 gunmen surrendered to him. Capt. Palmer got hit in the stomach and later died.

Sgt. Katzman was the hunter for rabbits in the outfit. 1st Sgt. Dobozy told the unit to button their shirts when standing in line for chow.

After Capt. Smith was wounded, Capt. Garbuit took over the Company. Jack Edwards and several others of Company K volunteered for night patrol. Capt. Garbuit got hit in the thigh and was sent back to the United States. Before leaving Capt. Garbuit told 1st Sgt. Dobozy "Don't let them mix up this company."

Capt. Carl Wallace took over after Capt. Garbuit left the company. Jack Edwards had a bazooka and a half dozen tanks came in and Jack with the other K Company men fired at the tanks for 57 minutes, but it didn't do anything.

## OUR TEAM MATES

*This supplement to the story “The Story of the 80th Division” is written to acknowledge the debt we owe to the attached organizations and units for their outstanding contributions to the great successes attained by our division during its victorious drive across France, Luxembourg, Germany and Austria. Their gallant efforts and ever present support in all engagements with the enemy has earned for them the admiration, respect and heartfelt gratitude of every member of the 80th Division.*

### 702 Tank Battalion

Joining the 80th Infantry at Craon, France on 8 August 1944, the 702nd Tank Battalion battled side by side with the “Blue Ridgers” up to the final day of triumph on the Enns River in Austria.

The capture of Argentan, the dash across France and the embattled bridgehead on the Moselle River gave testimony to the shattering power of the charging armor-infantry combination. As integral part of the 317, 318 and 319th Combat Teams, the companies of the 702nd smashed Nazi machine guns, pillboxes and tanks to aid the on rushing 80th.

On 8 October 1944, during the overwhelming attack on Mt. Toulon, key to the expanding Moselle bridgehead, the 702nd Tankers proved that they could make an “all armored” assault on the Supermen and drive it home. Dashing behind the infantry objective, the “Red Devils” disorganized the hostile rear elements and made possible an annihilating defeat of the surprised Nazi forces.

The Krauts in the Maginot Line, St. Avold, Rundstedts Ardennes Bulge, the Siegfried Line and the crumbling Nazi defenses in Germany and Austria wilted before the terrific blast of a well-coordinated and hard hitting Blue Ridge-Red Devil team.

## **633 AAA (AW) Battalion**

The 633rd AAA (AW) Battalion joined the Division in the vicinity of Evron, France on 9 August 1944. This association continued throughout the ten months of action seen by the “Blue Ridgers”. Each succeeding month the total of enemy planes damaged or knocked out of the skies increased as the 633rd AAA fulfilled its assignment of protecting ground troops and installations from air attacks. Always on the alert and ready to give the Luftwaffe a warm reception, the 633rd rendered many hostile air missions over the division area ineffective.

However, the number of planes damaged or destroyed tells only a part of the story of the 633rd's assistance in the advances across Europe. Equally noteworthy among the achievements of this organization were the achievements of this organization were the overhead ground support given to the infantry on many occasions. At Mt. Toulon, Mt. St. Jean, Morville Sur Seille, St. Avold, Masseler, and in the breaching of the Siegfried Line, the 633rd fired 424,209 rounds of 50-caliber tracer ammunition in front of the advancing doughboys and helped pave the way through stiff resistance.

## **610th Tank Destroyer Battalion**

On 9 August 1944, shortly after the 80th Division reached the shores of France, the 610th Tank Destroyer Battalion became a part of the “Blue Ridge” forces. IT participated in the bloody battle that closed the Argentan-Falaise Gap and destroyed seven enemy tanks, two 88's and numerous German vehicles in that engagement. During the Moselle River operation, the 610th helped repel strong enemy counterattacks and accounted for seventeen tanks. It added to its score in the drive through the Maginot Line, by knocking out thirteen pillboxes in one day. In support of the 80th Division's counterattack against the Ardennes Bulge, the 610th took a heavy toll of the defending Nazi tanks.

## **808th Tank Destroyer Battalion**

Becoming attached to the 80th Division on 25 September 1944, the 808th Tank Destroyer Battalion early proved its worth by providing anti-mechanized defense and maintaining roadblocks. By its timely and accurate firing of all assigned missions, during the all out push across the SEILLE River, it materially aided in the success of that operation. Until its release from the Division on 21 February 1945, the 808th continued to make the enemy feel its strength.

## **811th Tank Destroyer Battalion**

From 3 February 1945, the 811th Tank Destroyers have moved forward with the 80th Division. Besides accomplishing its primary mission of destroying the enemy armor, it has rendered invaluable assistance in demolishing enemy pillboxes and material. Many times the “dough's” went riding into battle on the decks of the 811 tank destroyers. So successful were the tank destroyers in deriving enemy personnel from buildings many “dough's” referred them as “town destroyers”.

## **OUT OF THE PAST...**

---

#### **EXPLOITATION PHASE, 15-18 SEPTEMBER**

The period of 15-18 September was devoted to a true operation of exploitation. Strong outposts were stationed on all main roads from CHAMBREY on the north to the RHINE-MARNE CANAL on the south. Raids by small infantry-tank teams were made on towns to the east to the limit of supporting artillery range. Reconnaissance was conducted by Troop D of the 25th Cavalry to a distance of approximately 15 kilometers to the east of MOYENVIC-BOURDONNAY highway. In addition to this, a perimeter defense was maintained on the high ground surrounding ARRACOURT on the south, east, and north.

On 15 September there was no heavy fighting, but large numbers of prisoners were taken and much enemy material was destroyed. At 1130 word was received from division headquarters that the 80th Infantry Division was receiving a heavy counter-attack near STE. GENEVIEVE and that the 1st Battalion of the 318th Infantry was to be returned to the 80th Division at once. It was further ordered that this infantry battalion be escorted by at least one company of medium tanks. At about 1500 the battalion started on its return to the STE. GENEVIEVE escorted by Company C of the 35th Tank Battalion. The operations officer of the 35th tank Battalion was placed in command of this entire force for the return movement. The empty trains of the combat command, carrying approximately 600 prisoners of war, accompanied this task force. Adjustments were made in the perimeter defense to compensate for the loss of infantry battalion and the Tank Company.

At 1800 word was received from this departing force that it had encountered enemy tanks near NOMENY and had suffered some damage. It planned to attack west in the direction of STE. GEVEVIEVE. Shortly thereafter radio contact was lost, nothing further being heard from the force until nearly 1200 on the 16th.

About 1200 on the 16th, Captain Strong, who had commanded the column of command trains accompanying this task force, returned to the bivouac area at ARRACOURT with his trains intact and carrying nearly 100 more prisoners than had departed with the day before. Escorting him was a platoon of Reconnaissance Troop of the 80th Infantry Division. This platoon had been cut off by the enemy near AULNOIS and had joined the task force late the afternoon before.

Captain Strong brought word that the task force had encountered the rear elements of the German force attacking STE. GENEVIEVE. The fight had begun shortly after 1800 of the previous afternoon and had continued through most of the night with each side attacking and, in return, receiving counter-attacks. Just before daylight the task force commander reached the decision that the trains seriously hampered his chances of fighting through the German lines without suffering excessive losses. He accordingly ordered them to return to the bivouac area at ARRACOURT and gave them the reconnaissance platoon, previously mentioned, as an escort. He had expected to attack toward STE. GENEVIEVE at daylight.

At about 1300 word was received from Headquarters 4th Armored Division that the attack of the task force had been successful and that it had retaken STE. Genevieve with heavy casualties to the enemy, while suffering only light losses itself. For the second time in three days a force from the combat command had taken STE. GENEVIEVE from a determined enemy. After assisting the 80th Division in an attack toward PONT-A-MOUSSON, Company C of the 35th returned to its battalion in the vicinity of LUNEVILLE, traveling a circuitous route to the west of NANCY to do so.

In the meantime Combat Command B was meeting determined resistance in its efforts to cross the RHINE-MARNE CANAL in the vicinity of MAIXE and SOMMERVILLEER, which is about 6 miles southwest of MAIXE. Accordingly, division headquarters ordered the CC Attack to clear the north bank of the canal to assist CC B in its crossing. At 90500 a task force of tanks, infantry, and artillery moved west to accomplish this mission. After clearing the woods west of EINVILLE and the towns of SERRES, HOEVILLE, DROUVILLE, and COURBESSEAUX, contact was made with CC B's 8th Tank Battalion west of DROUVILLE at HARRUCOURT late in the morning. This sweep had broken the German defense, causing the defenders to retreat to the north and west. Addition contact was made with elements of CC B at MAIXE. By 1300 this mission was complete and the task force returned to its original position. CC B crossed the rear of CCA moving to the north and took up position in the vicinity of FRESNES, on the high ground west of CHATEAU-SALINS.

From approximately 1600 on the afternoon of the 14th until CC B had completed clearing the area to the west of CC A, the command had been isolated. During this 48-hour period, 1614 prisoners of war had accumulated in the combat command PW cage. In addition to the requirement of guarding this number of prisoners, the additional problem of feeding and providing medical care for the numerous wounded became acute. Included in this bag of prisoners was one entire German field hospital with nearly 400 patients. The field hospital had been captured by the combat command surgeon late on the afternoon of the 15th, with a scalpel late on the afternoon of the 15th, with a scalpel as his major piece of armament. When he first observed, it had been attempting to escape with all wounded in ambulances. What seems at first amusing might have been disastrous to the surgeon in view of the large quantity of small arms and hand grenades which were discovered when the ambulances and personnel were search after reaching the PW cage.

17 September was uneventful except for receipt of a warning order from division that the command was to move in the direction of SARREGUEMINES early on 19 September.

When CC B had moved to FRESNES on 18 September, the reserve command of the division had occupied LUNEVILLE after the 2d Cavalry Group had received a severe mauling at the hands of the German 11th Panzer Division in the FORET DE PARROY. Now the reserve command was under heavy fire heavy fire from the same famous German division, and it appeared that an assault by that division was imminent. At 1200 the command was ordered to reinforce the reserve command with a minimum force of one medium Tank Company, one field Artillery battalion, and one platoon of tank destroyers. A force of this composition under the command of the executive officer of the 37th Tank Battalion began moving to LUNEVILLE at 1300.

At 1500 the entire command was alerted for possible movement to the south to repel the German attack expected in the LUNEVILLE area, should it develop. The 25 Cavalry Squadron would be attached to CC A and would arrive during the night to screen to the south and southeast. The German attack did not materialize, and the command settled down for the night shortly after dark. At 2300 the 37th Tank Battalion reported hearing an unidentified armored column approaching its position from the direction of BOURDONNAY and pulling off the road approximately a mile to the south of the outpost. Soon this column was identified as enemy and dispersed with artillery fire.

Shortly before midnight the 166th Combat Engineer Battalion moved into their bivouac area and was attached to the command.

## DISCUSSION

The four days of this particular phase of the operation can be truthfully called a typical operation of exploitation. It was typified by constant movement within the enemy line by constant movement within the enemy line and the use of fast-moving, aggressive task forces operating from a secure and easily defended base. Isolation for a 48-hour period caused no concern to any member of the command: rather it spurred them to greater alertness and activity. The flexibility of armor was typified in the ability of the command to shift the composition of its task force or combat teams to meet such changing situations as the necessity to assist other friendly elements. Examples of this were the movement of the one such force to STE. GENEVIEVE, another force to LUNEVILLE, and the sweep to the west by a third. Concurrently with these activities, plans were being made to continue the advance to the northeast and preliminary reconnaissance was made toward that end.

To illustrate the comparative damage that can be inflicted upon an enemy in such a situation, the losses suffered by the Germans during these four days included 1070 killed or captured, 16 large caliber guns destroyed, 8 tanks destroyed, and 232 miscellaneous vehicles destroyed. In contrast the total casualties of the combat command during these same four days were 3 killed, 15 wounded, and four tanks knocked out.
