VI. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

LEWIS C. HYERS, 42086496, Pfc, Co A, 317th Infantry, Army of the United States. For heroic achievement in FRANCE on 11 November 1944, in connection with military operations against an enemy of the United States. While nearing the last bridge left standing over the Nied River, Pfc HYERS encountered severe enemy fire, which temporarily delayed his company. With disregard for personal safety, he advanced through the hostile fire to cross the bridge and form a bridgehead and save the bridge on which his regiment and supporting armor could speedily cross. His bravery, aggressiveness, and sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from NEW YORK.

BRUCE K. TURNER, 31421405, S Sgt, Co C, 317th Infantry, Army of the United States. For heroic achievement in GERMANY from 20 to 22 February 1945, in connection with military operations against an enemy of the United States. Near BEDDINGEN, GERMANY, when his battalion was given the mission of taking an important hill, S Sgt TURNER, with utter disregard for personal safety, led a reconnaissance night patrol into enemy lines and secured valuable information which contributed greatly to the success of the attack. The courage, leadership, and devotion to duty displayed by S Sgt TURNER are commensurate with the highest traditions of the armed forces of the United States. Entered military service from MASSACHUSETTS.

VII. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel for meritorious service in connection with military operations against an enemy of the United States.

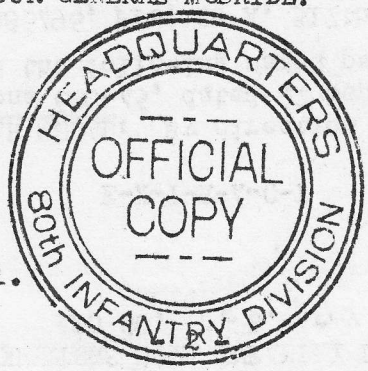

VI. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

LEWIS C. HYERS, 42086496, Pfc, Co A, 317th Infantry, Army of the United States. For heroic achievement in FRANCE on 11 November 1944, in connection with military operations against an enemy of the United States. While nearing the last bridge left standing over the Nied River, Pfc HYERS encountered severe enemy fire, which temporarily delayed his company. With disregard for personal safety, he advanced through the hostile fire to cross the bridge and form a bridgehead and save the bridge on which his regiment and supporting armor could speedily cross. His bravery, aggressiveness, and sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from NEW YORK.

BRUCE K. TURNER, 31421405, S Sgt, Co C, 317th Infantry, Army of the United States. For heroic achievement in GERMANY from 20 to 22 February 1945, in connection with military operations against an enemy of the United States. Near BEDDINGEN, GERMANY, when his battalion was given the mission of taking an important hill, S Sgt TURNER, with utter disregard for personal safety, led a reconnaissance night patrol into enemy lines and secured valuable information which contributed greatly to the success of the attack. The courage, leadership, and devotion to duty displayed by S Sgt TURNER are commensurate with the highest traditions of the armed forces of the United States. Entered military service from MASSACHUSETTS.

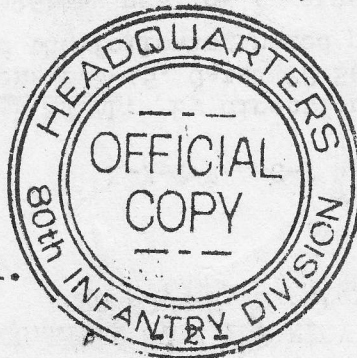
