I. AWARD OF SILVER STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named personnel:

THEODORE J. GLOWKA, 36977912, Pfc, Co B, 319th Infantry, Army of the United States. For gallantry in action in LUXEMBOURG on 8 January 1945, in connection with military operations against an enemy of the United States. At DAHL, LUXEMBOURG, when an estimated enemy company attacked Pfc GLOWKA'S position, he fought them off for an hour and a half, before withdrawing to a house. Even though wounded he refused to surrender and entered into hand to hand and room to room combat, until he forced twenty five of the enemy to surrender. His courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from MICHIGAN.

PRESTON A. IDEUS, 02011877, 2d Lt, MAC, 317th Infantry, Army of the United States. For gallantry in action in GERMANY on 10 April 1945, in connection with military operations against an enemy of the United States. At ALACH, GERMANY Lt IDEUS volunteered to go to the aid of wounded men still under fire from a hostile machine gun. With utter disregard for personal safety Lt IDEUS advanced over the exposed terrain and despite the increasing intensity of enemy fire administered aid and evacuated the casualties over the same hazardous route. His initiative, outstanding courage, and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from TEXAS.

JAMES P. KNIZE, 35837732, Pfc, Co G, 317th Infantry, Army of the United States. For gallantry in action in GERMANY on 10 April 1945, in connection with military operations against an enemy of the United States. At GISPERSLEBEN, GERMANY, Pfc KNIZE observed two comrades who had become casualties lying in an exposed position well forward of the front lines. With utter disregard for personal safety he advanced through severe hostile fire to aid and evacuate over the same route the one soldier still alive. The gallant action, initiative, and devotion to duty displayed by Pfc KNIZE are commensurate with the highest traditions of the armed forces of the United States. Entered military service from OHIO.

EARL D. McQUISTON, 33253557, S Sgt, Co D, 317th Infantry, Army of the United States. For gallantry in action in LUXEMBOURG on 27 January 1945, in connection with military operations against an enemy of the United States. Discovering a friendly patrol about to be overrun by a numerically superior enemy force, S Sgt McQUISTON voluntarily organized and led another group to assist this patrol. By deliberately exposing himself and cleverly deploying his men he succeeded in holding off the enemy until the patrol could occupy a more advantageous position. His leadership and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

II. AWARD OF SOLDIER'S MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Soldier's Medal is awarded the following named personnel:

ORLANDO J. FANTI, 31295614, Pfc, Hq Co 3d Bn, 317th Infantry, Army of the United States. For heroism not involving actual conflict with an enemy in AUSTRIA on 9 May 1945. In the vicinity of KIRCHDORF ad KREMS, AUSTRIA, a companion with whom Pfc FANTI was swimming, lost control of himself after diving into the pool. Noticing the condition of his comrade Pfc FANTI immediately swam to his rescue. His alertness, initiative, and thoughtfulness for his companions are commensurate with the highest traditions of the armed forces of the United States. Entered military service from MASSACHUSETTS.

III. AWARD OF BRONZE STAR MEDAL (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Bronze Star Medal previously awarded, a bronze Oak Leaf Cluster is awarded the following named personnel:

WILLIAM J. BURNS, 33355143, S Sgt, Hq Co 2d Bn, 317th Infantry, Army of the United States. For heroic achievement in GERMANY on 5 April 1945, in connection with military operations against an enemy of the United States. While on patrol in IHRINGSHAUSEN, GERMANY, S Sgt BURNS noticed an enemy garrison and with a companion stealthily captured two armed guards and an officer. By ordering the officer to have all men in a nearby building fall out and surrender in an orderly fashion, he was responsible for the capture of 311 enemy soldiers who would have been a serious threat to the advance of his battalion. His courage and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

IV. AWARD OF BRONZE STAR MEDAL (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Bronze Star Medal previously awarded, a bronze Oak Leaf Cluster is awarded the following named personnel:

JOSEPH R. HUGHES, 02009810, 1st Lt (then 2d Lt), Infantry, 319th Infantry, Army of the United States. For heroic achievement in GERMANY on 3 April 1945, in connection with military operations against an enemy of the United States. In the attack on OCHSHAUSEN, GERMANY, when Lt HUGHES' machine gun platoon was attacked from the flank by five hostile tanks, he courageously exposed himself to the enemy fire to replace his guns and direct their fire on the tanks, which kept them buttoned up until friendly tank destroyers were committed to repel them. His aggressiveness and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from WEST VIRGINIA.

CLAUDE Q. LITTLE, 34312439, Sgt, AT Co, 319th Infantry, Army of the United States. For heroic achievement in GERMANY on 14 April 1945, in connection with military operations against an enemy of the United States. At WEIMAR, GERMANY, when a convoy was delayed by a road block, Sgt LITTLE, with utter disregard for personal safety, drove his vehicle from a defilade to an exposed position from which he fired on and destroyed an enemy machine gun, thus allowing the company to deploy and destroy the road block. His courage and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from NORTH CAROLINA.

GEORGE F. McDONELL, 01296726, Capt (then 1st Lt), Infantry, 317th Infantry, Army of the United States. For heroic achievement in GERMANY from 20 to 23 February 1945, in connection with military operations against an enemy of the United States. During this period Capt McDONELL, a company commander, led his company in a heroic and superior manner. Despite hazardous terrain, inclement weather, and intense hostile fire he courageously inspired his men in the attack so as to capture every objective and 74 prisoners, with a loss of only three men. Capt McDONELL'S courage, leadership, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from ALABAMA.

V. AWARD OF BRONZE STAR MEDAL (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Bronze Star Medal previously awarded, a bronze Oak Leaf Cluster is awarded the following named personnel for meritorious service in connection with military operations against an enemy of the United States:

GEORGE N. CRAIG, 0296674, Major, GSC, Headquarters 80th Infantry Division, Army of the United States. For the period 1 December 1944, to 7 May 1945, in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA. Entered military service from INDIANA.

CLARENCE D. KNEPPER, 37725982, Tec 4, Btry C, 905th FA Battalion, Army of the United States. For the period 6 February 1945, to 7 May 1945, in LUXEMBOURG and GERMANY. Entered military service from KANSAS.

VI. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

ANTHONY J. BARTULEVY, 36861252, Tec 5, Hq Co, 317th Infantry, Army of the United States. For heroic achievement in GERMANY on 12 and 13 March 1945, in connection with military operations against an enemy of the United States. At OBER ZERF, GERMANY, Tec 5 BARTULEVY, under intense enemy fire, installed a switchboard in the town. For twenty four hours he remained at his post during which time he braved the severe artillery in order to repair severed lines. His technical skill, bravery, and devotion to duty afforded his unit with unbroken communications during a critical tactical situation and are in keeping with the highest traditions of the armed forces of the United States. Entered military service from MICHIGAN.

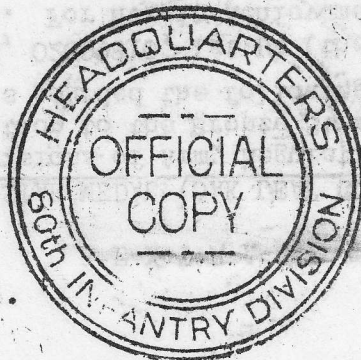
FRED R. BODKIN, 33441441, Tec 4, Hq Co, 702d Tank Battalion, Army of the United States. For heroic achievement in LUXEMBOURG on 25 December 1944, in connection with military operations against an enemy of the United States. At KEHMEN, LUXEMBOURG, Tec 4 BODKIN observed his platoon leader lying wounded on another tank. Despite the intense enemy fire he maneuvered his vehicle close to the platoon leader's and, with utter disregard for personal safety, dismounted in the face of small arms fire to carry his wounded comrade to his own tank and safety. His initiative, courage, and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

ALFRED W. BUCHANAN, 38119045, Pfc, MD, 319th Infantry, Army of the United States. For heroic service in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA from 7 August 1944, to 8 May 1945, in connection with military operations against an enemy of the United States. During this period Pfc BUCHANAN performed his duties as aid man in a heroic and exemplary manner. With disregard for personal safety and under all types of severe hostile fire, he has shown determination in aiding wounded comrades. His courage and sincere devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from TEXAS.

VII. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

CHARLES D. CLEMENTS, 02009793, 1st Lt (then T Sgt and 2d Lt), Infantry, 319th Infantry, Army of the United States. For heroic service in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA from 7 August 1944, to 8 May 1945, in connection with military operations against an enemy of the United States. During this period Lt CLEMENTS performed his duties as Machine Gun Platoon Leader with competence and outstanding ability. By his tactical knowledge, proven in many encounters, he has earned the confidence of his men. The courage, leadership, and devotion to duty displayed by Lt CLEMENTS are commensurate with the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

WELBY L. HATTON, 33191626, Tec 5, (then Pfc), MD, 317th Infantry, Army of the United States. For heroic achievement in LUXEMBOURG on 26 January 1945, in connection with military operations against an enemy of the United States. During the attack on PINSCHÉ, LUXEMBOURG, Tec 5 HATTON, an aid man, advanced through hostile artillery, mortar, and small arms fire to rescue two comrades from an exposed position and successfully evacuate them. During the remainder of the attack he worked, constantly in the danger of enemy fire to aid and evacuate all casualties. His initiative, courage, and devotion to duty reflect great credit upon himself and the armed forces of the United States. Entered military service from WASHINGTON, D. C.

EDWARD L. JOYCE, 33213365, T Sgt (then S Sgt), Co A, 317th Infantry, Army of the United States. For heroic achievement in GERMANY on 21 February 1945, in connection with military operations against an enemy of the United States. In the vicinity of BETTINGEN, GERMANY, T Sgt JOYCE, a platoon guide, advanced over 300 yards of terrain exposed to severe hostile fire to receive orders from his company commander when the platoon commanders became casualties. Returning over the same hazardous route he reorganized and rallied a squad and successfully completed its mission of destroying a machine gun position. His courage and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from NORTH CAROLINA.

HENRY MARSZALEK, 35358805, Pfc, Co B, 319th Infantry, Army of the United States. For heroic achievement in LUXEMBOURG and GERMANY from 7 to 9 February 1945, in connection with military operations against an enemy of the United States. During the assault on the Siegfried Line, Pfc MARSZALEK, a runner, was called upon to deliver verbal messages because of the lack of wire communications. Despite open and hazardous terrain, all types of severe enemy fire, and frequent encounters with enemy patrols, he never faltered or failed in accomplishing his mission. Pfc MARSZALEK'S tenacity of purpose, courage, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from INDIANA.

THOMAS L. MERRICK, 01312582, 1st Lt, Infantry, 319th Infantry, Army of the United States. For heroic service in FRANCE, LUXEMBOURG, and GERMANY from 12 November 1944, to 2 April 1945, in connection with military operations against an enemy of the United States. During this period Lt MERRICK performed his duties as rifle platoon leader and executive officer with competence and outstanding ability. By his tactical knowledge, proven in many encounters, he has earned the confidence of his men. The courage, leadership, and devotion to duty displayed by Lt MERRICK are commensurate with the highest traditions of the armed forces of the United States. Entered military service from CALIFORNIA.

EDWARD R. O'CONNOR, 20235042, Tec 5, Hq Btry, 315th FA Battalion, Army of the United States. For heroic achievement in FRANCE on 1 November 1944, in connection with military operations against an enemy of the United States. When communication lines were cut near LETTRICOURT, FRANCE, Tec 5 O'CONNOR, a radio operator, left the comparative safety of his foxhole, advanced through a severe artillery barrage, and located and repaired the break in the wires. His heroic action, courage, and devotion to duty were responsible for the maintenance of vital communications during the infantry's attack and exemplify the highest traditions of the armed forces of the United States. Entered military service from NEW JERSEY.

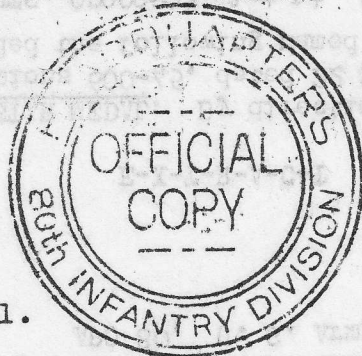
ALBERT L. RAPONI, 14131066, Pfc, MD, 319th Infantry, Army of the United States. For heroic service in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA from 20 September 1944, to 8 May 1945, in connection with military operations against an enemy of the United States. During this period Pfc RAPONI performed his duties as aid man in a heroic and exemplary manner. With disregard for personal safety and under all types of severe hostile fire he has shown determination in aiding wounded comrades. His courage and sincere devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from ALABAMA.

JOSEPH E. ROWAN, 0374349, 1st Lt, Infantry, 317th Infantry, Army of the United States. For heroic achievement in GERMANY on 14 March 1945, in connection with military operations against an enemy of the United States. At OBER ZERF, GERMANY, when his regiment encountered severe enemy artillery, nebelwerfer, and small arms fire, Lt ROWAN, Regimental Communications Officer, by exercising initiative and leadership, maintained unbroken communications among the units of the command. By exposing himself to the hostile fire he inspired and assisted his men in repairing severed lines. His courage and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from KANSAS.

VIII. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

BRENTON V. SCHOFIELD, 31294092, Cpl, Co B, 319th Infantry, Army of the United States. For heroic achievement in LUXEMBOURG and GERMANY from 7 to 9 February 1945, in connection with military operations against an enemy of the United States. During the assault on the Siegfried Line, Cpl SCHOFIELD, a runner, was called upon to deliver verbal messages because of the lack of wire communications. Despite open and hazardous terrain, all types of severe enemy fire, and frequent encounters with enemy patrols, he never faltered or failed in accomplishing his mission. Cpl SCHOFIELD'S tenacity of purpose, courage, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from MASSACHUSETTS.

RUSSELL H. SINES, 35386437, T Sgt, Co L, 317th Infantry, Army of the United States. For heroic achievement in GERMANY on 10 April 1945, in connection with military operations against an enemy of the United States. When his company was temporarily delayed by severe enemy fire near ALACH, GERMANY, T Sgt SINES, with utter disregard for safety, exposed himself so as to direct accurate mortar fire on the enemy positions. By his courageous actions he was responsible for the wounding of forty and the capture of one hundred of the hostile force. His bravery and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from WEST VIRGINIA.

EARL W. SPARKS, 37211818, Pfc, MD, 319th Infantry, Army of the United States. For heroic service in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA from 7 August 1944, to 8 May 1945, in connection with military operations against an enemy of the United States. During this period Pfc SPARKS performed his duties as a man in a heroic and exemplary manner. With disregard for personal safety and under all types of severe hostile fire he has shown determination in aiding wounded comrades. His courage and sincere devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from KANSAS.

ROBERT M. WALKER, 01311453, Capt, Infantry, 317th Infantry, Army of the United States. For heroic achievement in LUXEMBOURG on 24 and 25 January 1945, in connection with military operations against an enemy of the United States. While moving from an assembly area west of WILWERWILTZ, LUXEMBOURG, one battalion became separated from the task force. Displaying initiative and resourcefulness, Capt WALKER located the battalion, selected a route which saved time, and effected the juncture with the task force in the successful attack across the Clert River. His bravery and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from INDIANA.

WILLARD T. WINBORNE, 01329655, 1st Lt (then 2d Lt), Infantry, 319th Infantry, Army of the United States. For heroic achievement in GERMANY on 15 April 1945, in connection with military operations against an enemy of the United States. While attacking GLAUCHAU, GERMANY, Lt WINBORNE heroically and successfully led his platoon in an attack, despite intense enemy fire, on a group of buildings. Employing his tactical ability and excellent fire control he and his platoon annihilated 18 of the enemy soldiers. His outstanding leadership, aggressiveness, and sincere devotion to duty reflect great credit upon himself and the armed forces of the United States. Entered military service from NORTH CAROLINA.

EUGENE M. WING, 33832598, Tec 5 (then Pvt), MD, 317th Infantry, Army of the United States. For heroic achievement in GERMANY on 21 February 1945, in connection with military operations against an enemy of the United States. While attacking a high hill near HALSDORF, GERMANY, an infantry company was temporarily delayed and subjected to intense enemy fire which caused many casualties. Leaving his place of comparative safety in the rear of the company, Tec 5 Wing, with utter disregard for safety and enemy fire, moved about the hazardous area to aid and evacuate his comrades. Tec 5 Wing's courage, thoughtfulness for those he served, and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

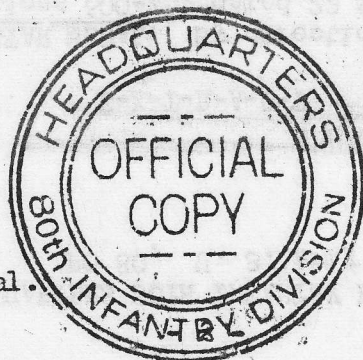
