AWARD OF PURPLE HEART (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Purple Heart and two bronze Oak Leaf Clusters previously awarded, a third bronze Oak Leaf Cluster is awarded Pfc Forest M. Sheeley, 35408418, Inf, for wounds received as a result of enemy action in Germany on 23 February 1945.

II. AWARD OF PURPLE HEART (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Purple Heart and bronze Oak Leaf Cluster previously awarded, a second bronze Oak Leaf Cluster is awarded Tec 4 Chris J.
