During the period 8 - 11 November 1944, Capt McIlmail distinguished himself by the highly exemplary manner in which he led his rifle company in successful assaults from the Seille River to the vicinity of the German border resulting in the seizure of three towns, the destruction of strongly fortified enemy positions and the capture of many prisoners. Although seriously wounded in an assault, Capt McIlmail refused to be evacuated until he had formulated complete plans for the relinquishment of his command. The brilliant leadership, superior tactical ability, and sincere devotion to duty displayed by Capt McIlmail are commensurate with the finest traditions of the armed forces of the United States. Entered military service from Rhode Island.

ALBERT S. TOSI, 0416099, Lt Col, Inf, Army of the United States. For meritorious service in France during the period 8 - 13 November 1944, in connection with military operations against an enemy of the United States. Entered military service from Massachusetts.
