I. AWARD OF BRONZE STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

James C. Balazs, 35408099, 1st Sgt. Inf. Army of the United States. For heroic achievement in France on 21 November 1944, in connection with military operations against an enemy of the United States. On 21 November 1944, the company with which 1st Sgt Balazs served had the mission of outposting an objective. 1st Sgt Balazs was to follow the company with his personnel group and establish a command post. Upon his arrival he found that the company had bypassed the objective and was encircled by the enemy. 1st Sgt Balazs then outposted the objective with his group and sent out patrols to contact the company, maintaining contact with his battalion until he had located his company. The initiative, aggressiveness, and devotion to duty demonstrated by 1st Sgt Balazs are in keeping with the finest traditions of the armed forces of the United States. Entered military service from Ohio.

Walter J. Bendrick, 33240945, Pfc, Inf, Army of the United States. For heroic achievement in France on 10 November 1944, in connection with military operations against an enemy of the United States. On 10 November 1944. the squad with which Pfc Bendrick served as Machine Gunner had the mission of supporting a battalion attack on the enemy. As the leading elements of the battalion began to cross the line of departure they were subjected to heavy automatic weapons and mortar fire, temporarily delaying the advance. With total disregard for his own safety, Pfc Bendrick immediately set up his machine gun and began firing upon the enemy emplacements, successfully destroying them. During the course of the fighting Pfc Bendrick had two machine guns destroyed. from under him which were replaced so that he could continue firing. His actions enabled the battalion to proceed and accomplish the assigned mission. The courage, aggressiveness, and loyal devotion to duty displayed by Pfc Bendrick exemplify the finest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Charles J. Bennett, 39096424, S Sgt, Inf, Army of the United States. For heroic achievement in France on 10 September 1944, in connection with military operations against an enemy of the United States. During an attack on the enemy on 10 September 1944, S Sgt Bennett, Observer and Section Leader of an 81mm Mortar Platoon, displayed cool courage and utter disregard for his own safety, while under direct fire from enemy artillery, machine gun, and rifle fire, to maintain an observation post and direct accurate moenemy positions. His actions enabled the company he served to suc
