I. AWARD OF SILVER STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named personnel:

General Barcone, 42137616, Pfc, Inf, Army of the United States. For gallantry in action in Germany on 21 February 1945, in connection with military operations against an enemy of the United States. On 21 February 1945, the rifle company with which Pfc Barcone was serving as a rifleman in an attack near Hommer-dingen, Germany, was temporarily delayed by severe fire from an enemy position approximately seventy five yards distant. Realizing that many casualties would be inflicted upon his platoon if its fire continued, he charged the position firing as he ran, killing one, wounding another, and forcing two more to surrender. This courageous act by Pfc Barcone allowed his company to advance and win its objective. His bravery, aggressiveness, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from New York.

Edward H. Poring, 38203361, Tec 5, MD, Army of the United States. For gallantry in action in Luxembourg on 25 December 1944, in connection with military operations against an enemy of the United States. On 25 December 1944, Tec 5 Boring, an aid man, was evacuating battle casualties near Kehmen, Luxembourg. Receiving word that an officer was wounded in the town he drove his vehicle to the injured man without hesitation despite the severe small arms and mortar fire directed at him. Disregarding the danger to himself, Tec 5 Boring placed the officer and another casualty, whom he located, on his vehicle and through heavy enemy fire evacuated them to safety. His courage, initiative, and supreme devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Texas.

Andrew E. Ciarniello, 35925398, Sgt, Inf, Army of the United States. For gallantry in action in Luxembourg on 26 December 1944, in connection with military operations against an enemy of the United States. On 26 December 1944, Sgt Ciarniello, a mortar section leader, was detailed to support the entrance of a rifle platoon into the town of Scheidel, Luxembourg. The advance of the rifle platoon was hampered by small arms fire. Upon surveying the tactical situation Sgt Ciarniello determined that the use of mortars would endanger the lives of his comrades. Therefore, he secured an automatic rifle and without regard for his own safety advanced and so effectively fired on the enemy positions that their fire was routralized. He then led the assault into the town until wounded. His bravery, leadership, and sincere devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Ohio.

CHARLES W. GARBUTT, 01299227, 1st Lt, Inf, Army of the United States. For gallantry in action in Luxembourg on 25 and 26 January 1945, in connection with military operations against an enemy of the United States. On 25 January 1945, while Lt Garbutt, a company commander, was leading a five man reconnaissance patrol into Wilwerwiltz, Luxembour, an enemy mine explosion injured two of his men. After treating the casualties and arranging for their evacuation, he completed his mission. Thereafter he led his company into the town, set up outpost positions, and sent out patrols in preparation for an attack on the following day. On 20 January 1945, Lt Garbutt led a platoon across the Clert River to establish a bridgehead, and then to spearhead the attack on the town of Pintsche, Luxembourg. The capture of the town came as a result of a skillfully executed flanking maneuver by the platoon led by Lt Garbutt. His conspicuous bravery, brilliant leadership, and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

John R. Monahan, 7022657, Sgt, Inf, Army of the United States. For gallantry in action in Germany on 22 February 1945, in connection with military operations against an enemy of the United States. On 22 February 1945, Sgt. Monahan, accompanied by another soldier, was acting as a guide for his attacking company near Huttingen, Germany, when it was subjected to intense fire from an enemy position three hundred yards distant on the right flank. Fearlessly he crawled to a point seventy five yards from the enemy where he jumped to his feet and charged, firing his rifle. Part way to the enemy position he fell to the ground and threw hand grenades, killing several of the enemy and forcing twenty two soldiers and an officer to surrender. His aggressiveness, bravery, and sincere devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Ercole Olivetti, 33348119, Sgt, Inf, Army of the United States. For gallantry in action in Luxembourg on 24 December 1944, in connection with military operations against an enemy of the United States. During a violent enemy attack against Heiderscheid, Luxembourg, Sgt Olivetti, an infantry company communication sergeant, observed an enemy armored column approaching. Quickly he selected an advantageous position and calmly held his fire until enemy tanks had passed. Then he opened fire on enemy infantry troops, taking a heavy toll in wounded and killed. When threatened by three machine gun squads he annihilated two and forced the other to withdraw. His sound judgment and aggressiveness not only gave his comrades sufficient time to cope with the situation, but were responsible for the disorganization and rout of a superior enemy force. His resourcefulness, aggressiveness, and sincere devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Michael J. Pelc, 33321143, S Sgt, Inf, Army of the United States. For gallantry in action in Belgium on 27 December 1944, in connection with military operations against an enemy of the United States. During the attack on Honville, Belgium, on 27 December 1944, the company in which S Sgt Pelc was serving as machine gun section leader, was temporarily delayed and subjected to intense machine gun fire from a well dura in an applicament. After attempts to destroy the position with rifle and automatic fire had failed, S Sgt Pelc, voluntarily and with utter disregard for personal safety, crawled over one hundred yards of open terrain under severe hostile fire to assault the position singlehandedly. His audacious act was responsible for the capture of five enemy soldiers and the rapid advance of his appany toward the objective. S A Pelc's aggressiveness.

- Grald L. Schira, 36864243, Pfc, Inf, Army of the United States. For gallantry in action in Germany on 16 March 1945, in connection with military operations against an enemy of the United States. During the attack on Weiskirchen, Germany, on 16 March 1945, Pfc Schira was serving as a rifleman with a company that was delayed by a well hidden enemy weapon. Immediately, Pfc Schira dropped to the street, attached a grenade to his rifle, and, despite the intense fire directed at him, destroyed the enemy position. Later in the same day when the company was again delayed by enemy fire he fearlessly retrieved an automatic rifle of a fallen comrade, and returned fire causing their surrender. His boldness, initiative, and sincere devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Michigan.
- Co Clarence H. Schnorenberg, 36806706, S Sgt (then Cpl), Inf, Army of the United States. For gallantry in action in Germany on 18 February 1945, in connection with military operations against an enemy of the United States. On 18 February 1945, S Sgt Schnorenberg was acting as platoon sergeant of the rear guard platoon of a rifle company in the attack on Hommerdingen, Germany. During the course of the attack the company had passed a well camouflaged enemy position which threatened to inflict severe casualties from the rear. Realizing the seriousness of the situation, S Sgt Schnorenberg, alone and unassisted, courageously charged the position through withering fire. Using his rifle and hand grenades, he killed two, wounded four, and captured ten enemy soldiers, thereby saving his company many casualties. His bravery, aggressiveness, and sincere devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Wisconsin.

Comrad L. Reaves, 38629449, S Sgt, Inf, Army of the United States. For gallantry in action in France on 28 November 1944, in connection with military operations against an enemy of the United States. On 28 November 1944, an enemy attack on Farbersviller, France, penetrated the outer perimeter of a battalion defensive position and threatened friendly artillery positions. When his platoon leader and platoon sergeant were wounded, S Sgt Reaves, a squad leader, immediately assumed command and rallied his men to withstand an enemy force of approximately one hundred infantrymen and five tanks. As a result of S Sgt Reaves' outstanding leadership and initiative, the enemy was delayed and the artillery positions protected until friendly tanks repulsed the attack. His courage, leadership, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Texas.

George H. Van Veghel, 36252915, S Sgt (then Tec 4), MD, Army of the United States. For gallantry in action in France on 13 and 14 September 1944, in connection with military operations against an enemy of the United States. On 13 September 1944, near Loisy, France, S Sgt Van Veghel, an aid man with a rifle company, evacuated five seriously wounded men by carrying them on his back over a mile of rough ground constantly under fire. On the following day, when he and a litter bearer were threatened by an armed enemy soldier, S Sgt Van Veghel fearlessly attacked and subdued him. Later in crossing a river the litter bearer was about to drown when S Sgt Van Veghel promptly risked his life to save him. His fearlessness and unselfish devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Wisconsin.
