I. AWARD OF BRONZE STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named Officer and Enlisted Men:

James L. Comer, 34501458, Sgt, FA, Army of the United States. For meritorious service in France during the period 25 September 1944, to 1 December 1944, in connection with military operations against an enemy of the United States. Entered military service from Tennessee.

Donald T. Dandurand, 37587626, Pvt, Inf, Army of the United States. For heroic service in France during the period 12 October 1944, to 7 November 1944, in connection with military operations against an enemy of the United States. During the period 12 October 1944, to 7 November 1944, Pvt Dandurand distinguished himself in performing his duties as Scout. Continually he made hazardous reconnaissance in enemy held territory, crossing a water barrier by rubber boat into terrain strongly defended by automatic weapons, mines, and booby traps. He overcame every hazard and successfully completed each mission, bringing back invaluable information. His unselfish devotion to duty, resourcefulness, and courage reflect great credit upon himself and the armed forces of the United States. Entered military service from Minnesota.

Fred L. Day, 34595345, Tec 4, FA, Army of the United States. For meritorious service in France during the period 25 September 1944, to 1 December 1944, in connection with military operations against an enemy of the United States. Entered military service from North Carolina.

Garold E. Dice, 20643581, Sgt, FA, Army of the United States. For meritorious service in France during the period 25 September 1944, to 1 December 1944, in connection with military operations against an enemy of the United States. Entered military service from Michigan.

Richard W. Downar, 37453725, M Sgt, Inf, Army of the United States. For meritorious service in France during the period 6 August 1944, to 9 December 1944, in connection with military operations against an enemy of the United States. Entered military service from Nebraska.


