Ralph S. Lugan, 38538682, Pvt, Inf, Army of the United States. For gallantry in action in France on 25 November 1944, in connection with military operations against an enemy of the United States. On 25 November 1944, Pvt Lugan, a rifleman, participated in an assault on the enemy who were entrenched behind concrete fortifications creating a ridge. Serious casualties were encountered from one of the machine guns emplaced in a pillbox. Although the enemy had perfect observation, and an assault meant running up the hill under direct fire, Pvt Lugan and a comrade voluntarily charged the pillbox. Hurling hand granades, they succeeded in destroying the machine gun, capturing fifteen of the enemy, and enabling the platoon to advance. The bravery, aggressiveness, and sincere devotion to duty displayed by Pvt Lugan are commensurate with the finest traditions of the armed forces of the United States. Entered military service from Texas.

DANIEL M. MOYER, 01308999, 1st Lt, Inf, Army of the United States. For gallantry in action in France on 28 November 1944, in connection with military operations against an enemy of the United States. On 28 November 1941, 1st Lt Moyer, serving as Company Commander, personally led his company in an assault on the enemy, having his unit pass through the lead company, then temporarily halted by the intense enemy fire. Despite wounds in his chest and arm he continued to lead his men until the objective was attained. The bravery, outstanding leadership, and loyal devotion to duty displayed by 1st It Moyer exemplify the finest traditions of the armed forces of the United States. Entered military service from West Virginia.

Alfredo Trevino, 38555666, Pvt, Inf, Army of the United States. For gallantry in action in France on 25 November 1944, in connection with military operations against an enemy of the United States. On 25 November 1944, Pvt Trevino, a rifleman, participated in an assault on the enemy who were entrenched behind concrete fortifications cresting a ridge. Serious casualties Were encountered from one of the machine guns emplaced in a pillbox. II. AWARD OF BRONZE STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following Officer and Enlisted Men:

Chester E. Amos, 35618554, Pfc, Cav, Army of the United States. For heroic achievement in France on 15 September 1944, in connection with military operations against an enemy of the United States. On 15 September 1944, Pfc Amos was serving with a platoon in a reconnaissance mission as a machine gunner of the point vehicle. Proceeding in open column formation the platoon suddenly received fire from two enemy machine guns. Although openly exposed to the heavy enemy fire, Pfc Amos manned his weapon, returning fire with accuracy and effectiveness, forcing the enemy to withdraw and permitting the platoon to maneuver into combat formation and later rout the opposing forces. His courage, resourcefulness, and constant devotion to duty exemplify the finest traditions of the armed forces of the United States. Entered military service from Ohio.

Norman Jacobsen, 30460278, Pfc, Inf, A my of the United States. For heroic achievement in France on 20 August 1944, in connection with military operations against an enemy of the United States. On 20 August 1944, the company with which Pfc Jacobsen served participated in an attack on the enemy. An enemy tank in the sector had by direct fire temporarily halted the advance. Securing a bazooka, Pfc Jacobsen with utter disregard for his own safety walked boldly toward the encoming tank firing two rounds of ammunition which forced it to withdraw and allowed his plateon to advance. The personal courage, aggressiveness, and sincere devotion to duty displayed by Pfc Jacobsen exemplify the finest traditions of the armed forces of the United States. Entered military service from Washington.

GEORGE W. KANE, 01058859, 2d Lt, Inf., Army of the United States. For heroic achievement in France on 2 December 1944, in connection with military operations against an enemy of the United States. On 2 December 1944, 2d Lt Kane led a patrol into enemy area. The patrol was so skillfully conducted that at no time did it draw fire from the enemy. He obtained valuable and necessary information which was of great importance in completing plans for the success of the assault on the following day. The initiative, leadership, and sincere devotion to duty displayed by 2d Lt Kane are commensurate with the finest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Wendell A. Maine, 37, 142, Pfc, Inf, Army of the United States. For heroic achievement in France on 13 September 1944, in connection with the properations again an enemy of the United States. In 13 September 1944, and the states are supplied to the United States.

His courage, resourcefulness and devotion to duty exemplify the finest traditions of the armed forces of the United States. Entered military service from Iowa.

James Hr. Maneilly, 35388223, S Sgt, Cav, Army of the United States. For heroic achievement in France on 23 November 1944, in connection with military operations against an enemy of the United States. On 23 November 1944, the 1st plateon of a reconnaissance unit had the mission of reconnaissance to the regimental front. It advanced to a town without contacting enemy forces, but was delayed for the night because of blown bridges. The next morning, shortly after the plateon leader had left to make a personal reconnaissance of the river for a crossing site, an enemy combat patrol heavily armed with automatic weapons and bazookas opened fire on the plateon. Despite the unavoidable confusion, S Sgt Maneilly quickly organized the plateon and returned fire with such effectiveness that four enemy were killed and seven taken prisoner, the remainder being forced to withdraw. The personal bravery, inspired leadership, and sincere evotion to duty displayed by S Sgt Maneilly exemplify the finest traditions of the armed forces of the United States. Entered military service from Ohio.

Carrol W. Motley, 15058414, Sgt, Inf, Army of the United States. For heroic achievement in France on 13 September 1944, in connection with military operations against an enemy of the United States. On 13 September 1944, in an attack on the enemy, friendly supporting tanks ran low on ammunition. Voluntarily, and with utter disregard of personal safety, Sgt Motley and a comrade set out in a vehicle, driving over enemy infested roads to replenish the depleted ammunition supply, successfully accomplishing the mission and relieving a critical situation. The courage, determination, and zealous devotion to duty displayed by Sgt Motley exemplify the finest traditions of the armed forces of the United States. Entered military service from West Virginia.
