I. AWARD OF SILVER STAR (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Silver Star Medal previously awarded, a bronze Oak Leaf Cluster is awarded the following named personnel:

MELVIN F. SCHNELLER, 02046814, 1st Lt, MAC, Army of the United States. For gallantry in action in Germany on 16 March 1945, in connection with military operations against an enemy of the United States. On 16 March 1945, during the pitched battle for Weiskirchen, Germany, Lt Schneller, an ambulance officer, disregarding his own personal safety, led his ambulances into the town over roads which were under heavy enemy fire. Despite the fierce street fighting, he moved from house to house locating and giving aid to the casualties, and after selecting the more seriously wounded cases he removed them from the fire fight over a circuitous route to the ambulances by which they were evacuated to an aid station. By courageously working throughout the day, Lt Schneller evacuated eighty four critically wounded men who otherwise would have died. His bravery, initiative, and sincere devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Wisconsin.

II. AWARD OF SILVER STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named personnel:

Harold A. Gratopp, 36130167, S Sgt, Armd, Army of the United States. For gallantry in action in France and Luxembourg on 18 September 1944, and 26 December 1944, in connection with military operations against an enemy of the United States. Throughout the campaign in France and Luxembourg, S Sgt Gratopp ably commanded his tank platoon when the platoon leader was evacuated with wounds. At Bezaumont, France, although his tank was hit and his gunner wounded, S Sgt Gratopp continued to attack and destroy two enemy tanks. Again at Kehmen, Luxembourg, on 26 December 1944, he took command of the platoon and led it through intense artillery fire to destroy three enemy pillboxes and to capture the enemy manning them. S Sgt Gratopp's courage, initiative, and sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Michigan.

TII. AWARD OF BRONZE STAR (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Bronze Star Medal previously awarded, a bronze Oak Leaf Cluster is awarded the following named personnel:

Wiley F. Duke, 38651186, S Sgt, Inf, Army of the United States. For heroic achievement in Germany on 16 February 1945, in connection with military operations against an enemy of the United States. On 16 February 1945, after having advanced into the Siegfried Line on the Luxembourg-German border, the company in which S Sgt Duke served as a squad leader, took up a defensive position to reorganize. During a heavy mortar and artillery barrage which the enemy fired into the defensive zone, two men were seriously wounded. With utter disregard for his own personal safety, S Sgt Duke and another soldier ran to the wounded men and carried them to the safety of a foxhole from which they were later evacuated. The courage, bravery, and devotion to duty displayed by S Sgt Duke are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Louisiana.

IV. AVARD OF BRONZE STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

Juan Acuna, 38217070, Pfc (then Pvt), MD, Army of the United States. For heroic achievement in Luxembourg on 26 January 1945, in connection with military operations against an enemy of the United States. In an attack on Bockholz, Luxembourg, on 26 January 1945, a seriously wounded soldier in the forward elements needed medical aid and immediate evacuation. Pfc Acuna, a company aid man, crawled forward under intense enemy fire to administer aid to the wounded man and then aided in moving him to a protected position from which he could be safely evacuated. Pfc Acuna's courage, skill, and devotion to duty saved the wounded soldier's life and exemplify the highest traditions of the armed forces of the United States. Entered military service from Texas.

ALFRED R. BORDEN, 0441059, 1st Lt, Inf, Army of the United States.

For heroic achievement in Germany on 15 March 1945, in connection with military operations against an enemy of the United States. On 15 March 1945, near Scheiden, Germany, Lt Borden, an infantry company executive officer, was assigned the command of a platoon during the fierce fight with the enemy. Assuming command under fire, Lt Borden reorganized the platoon and by leading a well coordinated attack captured an enemy machine gun emplacement inflicting numerous casualties on the enemy. Lt Borden's courage, leadership, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from New York.

Ollon Gray, 34796005, S Sgt (then Pfc), Inf, Army of the United States. For heroic achievement in Germany on 16 February 1945, in connection with military operations against an enemy of the United States. On 16 February 1945, after having advanced into the Siegfried Line on the Luxembourg-German border, the company in which S Sgt Gray served as a squad leader, took up a defensive position to reorganize. During a heavy mortar and artillery barrage which the enemy fired into the defensive zone, two men were seriously wounded. With utter disregard for his own personal safety, S Sgt Gray and another soldier ran to the

wounded men and carried them to the safety of a foxhole from which they were later evacuated. The courage, bravery, and devotion to duty displayed by S Sgt Gray are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Florida.

Joseph P. Hancock, 32592225, S Sgt, Inf, Army of the United States. For heroic achievement in Luxembourg on 24 January 1945, in connection with military operations against an enemy of the United States. While on a motorized patrol near Wilwerwiltz, Luxembourg, on 24 January 1945, S Sgt Hancock, a squad leader, dismounted and preceded the vehicles along a road which he believed contained mines. After advancing a short distance he accidentally detonated well concealed mine, which broke his log and severely lacerated his foot. Despite these painful wounds, S Sgt Hancock insisted on returning to make a report of the reconnaissance before being evacuated. His courage and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from New Jersey.

Paul D. Poston, 34128724, Sgt, Inf, Army of the United States. For heroic achievement in France on 11 and 12 November 1944, in connection with military operations against an enemy of the United States. On 11 and 12 November 1944, while his regiment was expanding a bridgehead over the Neid River near Hans-sur-Neid, France, Sgt Poston, Regimental Communications Sergeant, established and, without relief, maintained radao communication from the Regimental S-2 to the Division G-2. As the enemy realized the importance of the bridge, they fired intense artillery and mortar fire into the area in an attempt to destroy it. Sgt Poston remained throughout the merciless barrage and by keeping the communication flowing rendered invaluable aid to the division. His courage, bravery, and devotion to luty exemplify the highest traditions of the armed forces of the United States. Entered military service from South Carolina.

Conard L. Reives, 38629449, S Sgt, Inf, Army of the United States. For heroic achievement in Luxembourg on 26 December 1944, in connection with military operations against an enemy of the United States. In an attack near Scheidel, Luxembourg, on 26 December 1944, the platoon in which S Sgt Reaves served as guide was temporarily halted by intense enemy machine gun fire which inflicted several casualties in the platoon. Disregarding his own personal safety, S Sgt Reaves, acting fearlessly while exposed to enemy fire, supervised and aided in the evacuation of the wounled men. His courage, bravery, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Texas.

James H. Ripley, 37466623, Tec 5 (then Pfc), MD, Army of the United States. For heroic chievement in Germany on 6 March 1945, in connection with military operations against an enemy of the United States. On 6 March 1945, during a heavy enemy artillery concentration upon their position in a forest in Germany, two members of a tank crew were seriously injured by shell fragments. Pfc Ripley and an assistant drove a litter equipped truck to the side of the disabled tank without regard to the intense barrage and evacuated the wounded men to an aid station. Pfc Ripley's courage, disregard for personal safety, and sincere devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Nebraska.

Steven Sanchez, 37350737, T Sgt, Inf, Army of the United States. For heroic achievement in Luxembourg on 4 January 1945, in connection with military operations against an enemy of the United States. Near Welscheid, Luxembourg, at early evening on 4 January 1945, a numerically superior force of enemy troops attacked the plateon in which T Sgt Sanchez served as Plateon Sergeant. As heavy snows hid the attacking enemy from the artillery forward observers, T Sgt Sanchez, despite the intense artillery fire which accompanied the attack, climbed to the roof of a building from which he relayed fire orders to the observation posts. In this exposed position he adjusted artillery and mortar fire, materially aiding in repelling the enemy attack. T Sgt Sanchez's courage, initiative, and sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Colorado.

John F. Shaffer, 33321131, Tec 3 (then Tec 4), MD, Army of the United States. For heroic achievement in France on 20 August 1944, in connection with military operations against an enemy of the United States. On 20 August 1944, Tec 3 Shaffer, an aid man with a rifle company, personally freed three wounded men from a fiercely burning tank near Argentan, France. Disregarding the load of ammunition which might have exploded at any moment he worked swiftly and efficiently to render first aid and to evacuate the men to safety. Tec 3 Shaffer's courage, bravery, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Frederick W. Shaw, 31230327, Sgt (then Cpl), Inf, Army of the United States. For heroic achievement in Luxembourg on 25 December 1944, in connection with military operations against an enemy of the United States. During the attack on Kehmen, Luxembourg, on 25 December 1944, Sgt Shaw was in command of light machine gun section which had the mission of supporting a leading rifle platoon. When the tactical situation necessitated a withdrawal to a better position, Sgt Shaw observed that one of his men had been wounded and was unable to move. Disregarding the intense enemy fire and his own personal safety, Sgt Shaw carried the wounded man to safety. His courage, initiative, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Massachusetts.
