I. AWARD OF SILVER STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named personnel:

CHESTER E. AMOS, 35618554, Cpl (then Pfc), 80th Cavalry Reconnaissance Troop, United States Army. For gallantry in action in FRANCE on 23 November 1944, in connection with military operations against an enemy of the United States. Near FARBERSVILLER, FRANCE, Cpl AMOS boldly remained in his point vehicle to fire on and destroy an enemy gun position before seeking cover from the hostile fire. As a friendly car came into position to destroy remaining hostile weapons, he exposed himself, drew intense fire, and permitted his comrades to observe and destroy the enemy. Cpl AMOS' sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from OHIO.

ALFRED F. CANNIZZARO, 12124139, Pfc, Co H, 318th Infantry, United States Army. For gallantry in action in FRANCE on 15 September 1944, in connection with military operations against an enemy of the United States. At MOUSSON HILL, FRANCE, during a fierce enemy attack, Pfc CANNIZZARO found the observer and the driver of a half-track seriously stunded. Immediately, he loaded them in a vehicle and drove through severe fire concentrations. After reaching a river he braved the raging current to obtain a boat and evacuate his comrades. Pfc CALIZZARO'S gallantry and initiative exemplify the highest traditions of the armed forces of the United States. Entered military service from NEW YORK.

ARCHIE R. CLARK, 35359157, T Sgt (then S Sgt), Co B, 318th Infantry, United States Army. For gallantry in action in FRANCE on 12 November 1944, in connection with military operations against an enemy of the United States. Serving as company commander in an attack near LUCY, FRANCE, T Sgt CLARK'S battle weary company encountered severe hostile mortar, machine gun, and small arms fire. Advancing to the head of the company, he exposed himself to inspire his men to resume the attack, destroy the enemy, and take their objective. T Sgt CLARK'S leadership, gallantry, and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from TENNESSEE.

HOWARD E. GRANT, JR., 36186584, Sgt, Co B, 305th Engineer Battalion, United States Army. For gallantry in action in LUXEMBOURG on 24 December 1944, in connection with military operations against an enemy of the United States. Leading his patrol through enemy lines, Sgt GRANT infiltrated to enemy gun positions that he was to destroy. After making a reconnaissance of his objective, he skillfully led his men in placing high explosives on the hostile equipment, and despite the nearness of the enemy, ignited the charges and destroyed four guns, three vehicles, and the crews. Sgt GRANT'S courage and leadership exemplify the highest traditions of the armed forces of the United States. Entered military service from MICHIGAN.

FRANK T. LEMBO, 02010358, 1st Lt (then Sgt), CE, 305th Engineer Battalion, United States Army. For gallantry in action in FRANCE on 19 October 1944, in connection with military operations against an enemy of the United States. While deep in hostile territory, Lt LEMBO'S patrol was subjected to severe enemy fire and forced to withdraw. Alone, he voluntarily remained in exposed and hazardous territory to hold the hostile forces while his men moved to a position of safety. Lt LEMBO'S gallantry and devotion to duty saved his comrades from possible injury or capture and reflect great credit upon himself and the armed forces of the United States. Entered military service from NEW JERSEY.

JOSEPH M. VALE, Oll30371, 1st Lt, FA, 905th FA Battalion, United States Army. For gallantry in action in FRANCE on 17 November 1944, in connection with military operations against an enemy of the United States. In order to deliver effective fire on enemy positions near LANDROFF, FRANCE, Lt VALE, a forward observer, advanced through severe enemy fire to an advantageous position from where he destroyed many hostile guns. Then, he voluntarily led an infantry platoon in a successful attack to take the objective. Lt VALE'S courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from MISSOURI.

HOWARD D. WALTON, 33704858, Pvt, Co K, 318th Infantry, United States Army. For gallantry in action in GERMANY on 8 April 1945, in connection with military operations against an enemy of the United States. At ERFURT, GERMANY, Pvt WALTON, with disregard for safety, voluntarily attacked seven enemy troops that infiltrated friendly lines with two machine guns to harass troops. Skillfully, he advanced three hundred yards under severe enemy fire to engage the hostile troops in a fierce fire fight which destroyed or captured the entire enemy force. Pvt WALTON'S aggressiveness and gallantry exemplify the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

II. AWARD OF SILVER STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600745, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named personnel:

NELSON M. WALDRON, 33283996, Pfc, Hq Co, 319th Infantry, United States Army. For gallantry in action in FRANCE on 8 November 1944, in connection with military operations against an enemy of the United States. Near CRANECOURT, FRANCE, an artillery forward observer suffered shell shock and started to crawl to enemy lines. With disregard for personal safety, Pfc WALDRON voluntarily advanced through severe artillery fire to carry the officer to safety and to protect him from shell fragments with his own body. Pfc WALDRON'S courage and sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

LUIS W. YOCHUM, 33304962, Tec 5, Btry A, 315th FA Battalion, United States Army. For gallantry in action in GERMANY on 14 March 1945, in connection with military operations against an enemy of the United States. Within range of enemy small arms fire at OBER ZERF, GERMANY, Tec 5 YOCHUM advanced over hazardous and exposed terrain to aid four wounded comrades. With disregard for personal safety he administered aid despite the increasing intensity of heavy artillery and small arms fire to successfully evacuate them. The gallantry and sincere devotion to duty displayed by Tec 5 YOCHUM exemplify the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

III. AWARD OF SOLDIER'S MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Soldier's Medal is awarded the following named personnel:

BENJAMIN V. GAINER, 33497394, Pfc, Co F, 317th Infantry, United States Army. For heroism not involving actual conflict with an enemy in LUXEMBOURG on 23 December 1944. Near WELSCHEID, LUXEMBOURG, Pfc GAINER'S comrade fell 20 yards down a precipice before catching on a tree. At the risk of his life Pfc GAINER, without hesitation, crawled down the cliff to assist him in getting back to safety. Pfc GAINER'S conspicuous bravery, disregard for personal safety, and thoughtfulness for his comrades reflect great credit upon himself and the armed forces of the United States. Entered military service from PENNSYLVANIA.

JOSEPH W. PROST, 36041559, Sgt, Hq Btry, 313th FA Battalion, United States Army. For heroism not involving actual conflict with an enemy in FRANCE on 5 November 1944. While policing an area for salvage and ammunition near ATTON, FRANCE, a pile of shells exploded and injured Sgt PROST and his comrade. Despite his painful wound and flying shell fragments, Sgt PROST voluntarily carried his seriously wounded companion to safety and administered aid thereby saving his life. Sgt PROST'S courage and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from ILLINOIS.
