I. AWARD OF SILVER STAR MEDAL, POSTHUMOUSLY: By direction of the President, under provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded, posthumously, the following named personnel:

CHARLES P. FAIR, 33711035, Pfc, Co K, 319 Inf, United States Army. For gallantry in action in LUXEMBOURG: 21 January 1945, in connection with military operations against an enemy of the United States. During the attack on NOCHER, LUXEMBOURG, Pfc FAIR volunteered to destroy an observation post. Advancing through severe artillery fire, he stealthily infiltrated enemy lines, cut communications, and killed the enemy observers with a grenade. Pfc FAIR's initiative, aggressiveness, and devotion to duty eliminated a serious threat, accelerated the attack and exemplify the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

II. 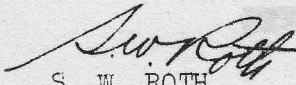

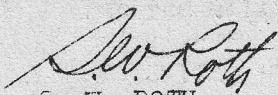
