I. AWARD OF BRONZE STAR MEDAL (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Brorge Star Medal previously awarded, a bronze Oak Leaf Cluster is awarded the following named personnel:

JAMES K. ANDERSON. 18059567, Sgt (then Pfc), Hq Co, 319th Infantry, United States Army. For heroic achievement in FRANCE on 5 September 1944, in connection with military operations against an enemy of the United States. Near VILLEY ST. ETIENNE, FRANCE, Sgt ANDERSON, with disregard for safety, manned a machine gun to protect his patrol when ambushed by an enemy platoon. Despite pressing hostile action, he remained at his post to cover his comrades' withdrawal to a more advantageous position. Sgt ANDERSON's courage and sincere devotion to duty reflect great credit upon himself and the armed forces of the United States. Entered military service from NEW MEXICO.

FREDERICK A. GRAEF, 0521912, Chaplain (Capt), Hq Special Troops, United States Army. For heroic achievement in FRANCE on 15 August 1944, in connection with military operations against an enemy of the United States. In the vicinity of EVRON, FRANCE, Chaplain GRAEF, on learning of two wounded soldiers lying in exposed territory, immediately went to their aid. Advancing through intense hostile mortar and sniper fire, he succeeded in evacuating the soldiers to safety and medical care. Chaplain GRAEF's courage and devotion to his men beyond the call of duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from MISSISSIPPI.

ROBERT R. J. KOCH, 19132949, Cpl, 80th Rcn Troop, United States Army. For heroic achievement in FRANCE on 15 September 1944, in connection with military operations against an enemy of the United States. When a strong enemy offensive threatened Pfc KOCH's command post, many valuable documents and equipment were endangered. With disregard for personal safety, he exposed himself to hostile fire, to fire continuously at the enemy force until his comrades could evacuate everything of value. Pfc KOCH's agressiveness, courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from ARIZONA.

RAY E. JONES, 37508091, Sgt (then Pfc), Co C, 319th Infantry, United States Army. For heroic achievement in LUXEMBOURG on 28 December 1944, in commection with military operations against an enemy of the United States. Near RINGOLD, LUXEMBOURG, intense enemy artillery concentrations repeatedly cut vital communication lines. With disregard for personal safety, 3gt JONES braved the severe fire to repair the wires and maintain communications paramount to the successful defense against hostile attacks. Sgt JONES' exceptional bravery and devotion to duty exemplify the highest traditions of the armed forces of the DECLASSIFIED United States. Entered military service from KANSAS. Authority MO 735017

MELVIN L. THOMPSON, 35749915, Pfc, Btry B, 905th FA Fattalion, Urited States Army. For heroic achievement in FRANCE on 10 November 1944, in connection with utilitary operations against an enemy of the United States. During the fieree battle for DELME RIDGE, FRANCE, Pfc THOMPSON displayed utter the regard for personal safety in performing his duties as radio operator. Advancing over exposed terrain, and under intense enemy fire, he maintained communications paradount to the success of this important operation. Pfc THOMPSON's bravery, aggressiveness, and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from OHIO.

ROBERT L. WALKER, 33410929, Tec 5, 80th Ren Troop, United States Army. For heroic achievement in AUSTRIA on 5 May 1945, in connection with military operations against an enemy of the United States. Near SCHWAMENSTADT, AUSTRIA, Tec 5 WALKER, boldly assaulted an enemy airfield. As a plane was about to take off, he shot the pilot and then so completely surprised other assalars of the installation that they surrendered before they could destroy valuable equipment already prepared for demolition. Tec 5 WALKER's initiative, courage, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

WILLIAM J. ZWICK, 33347899, Col, Btry B, 905th FA Battalion, United States Army. For heroic achievement in LUXEMBOURG on 24 December 1944, in collection with military operations against an enemy of the United States. At HETDERSCHEID, LUXEMBOURG, Col ZWICK remained at his post during a fierce enemy attack to maintain vital radio communications until a heavy volume of fire destroyed his equipment. Then, be acquired a rifle and courageously fought as an infintryman until the attack was checked and the enemy routed. The initiative and courageous devotion to duty displayed by Col ZWICK exemplif, the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

II. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

RAYMOND W. ACRE, 33278347, Pfc, Btry C, 315th FA Battalion, United States Army. For heroic achievement in GERMANY on 13 March 1945, in connection with military operations against an enemy of the United States. While registering on a position near OBER-ZERF, Pfc ACRE's gun section was subjected to a severe concentration of enemy artilleryfire. With disregard for personal safety, he remained at his post despite shells bursting within a few yards of his position, to complete his important mission. Pfc ACRE's courage and sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from PENNSYLVANIA.

ALFRED C. ANDERSEN, 37450077, S Sgt, Co C, 319th Infantry, United States Army. For heroic achievement in GERMANY on 12 February 1945, in connection with military operations against an enemy of the United States. Near WALLENDORF, GERMANY, a hostile emplacement temporarily delayed S Sgt ANDERSEN's company. With disregard for personal safety, he advanced through severe enemy fire to assault and capture the pillbox. The same night, he courageously led his men in halting an enemy attack to recapture the emplacement. S Sgt ANDERSEN's courage and leadership exemplify the highest traditions of the armed forces of the United States. Entered military service from NEBRASKA.

LINCOLN M. ANDRE, 35085092, S Sgt, Co E, 317th Infantry, United States Army. For heroic service in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA from 17 November 1944, to 8 May 1945, in connection with military operations against an enemy of the United States. During this period, S Sgt ANDRE performed duties as ammunition bearer, squad and section leader, and, on occasions, platoon leader, in a superior manner. Despite pressing enemy action, he displayed an utter disregard for personal safety to courageously lead his men in many successful encounters. S Sgt ANDRE's leadership, aggressiveness, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from KENTUCKY.

ARTHUR L. ASH, 0887612, 1st Lt, Inf, 317th Infantry, United States Army. For heroic service in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA from 6 August 1944, to 8 May 1945, in connection with military operations against an enemy of the United States. Serving as an anti-tank platoon leader during this period, Lt ASH performed his duties in a heroic and superior manner. At all times he displayed an utter disregard for personal safety, despite the constant hazards of combat conditions. The leadership, superior judgment, and courageous devotion to duty displayed by Lt ASH are commensurate with the highest traditions of the armed forces of the United States. III. AWARD OF BRONZE STAR MEDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as emended, the Bronze Star Medal is awarded the following named personnel:

ERNEST S. ISENBERG, 02005243, 2d Lt (then S Sgt), Hq 80th Infantry Division, United States Army. For heroic achievement in LUXEMBOURG and GERMANY from 14 February 1945 to 15 February 1945, in connection with military operations against an enemy of the United States. Near WALLENDORF, GERMANY, Lt ISENBERG braved severe enemy fire to cross exposed and hazardous terrain to enter a German bunker. By listening to conversation on the enemy telephone system, he gained valuable information that assisted the advance of his regiment. Lt ISENBERG's courage, initiative, and sincere devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from KANSAS.

WILLARD L. LINK, 33225890, Tec 5, AT Co, 319th Infantry, United States army. For heroic service in FRANCE, LUXEMBOURG, GERMANY, and AUSTRIA from 7 August 1944, to 8 May 1945, in connection with military operations against an enemy of the United States. Serving as a truck driver during this period, Tec 5 LINK performed his duties in a heroic manner. Despite the constant hazards of combat, he displayed disregard for personal safety to drive truck loads of urgently needed munitions through enemy artillery concentrations to front line troops. Tec 5 LINK's courage, initiative, and sincere devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from VIRGINIA.

CHARLES W. PARKER, 33939733, Pfc, Co D, 318th Infantry, United States Army. For heroic service in GERMANY from 9 February 1945 to 12 February 1945, in connection with military operations against an enemy of the United States.
