I. AWARD OF SILVER STAR EDAL: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named personnel:

FRANKLIN O. BERKHOUSE, 33948065, Pfc, Co B, 317th Infantry, United States Army. For gallantry in action in CERMANY on 13 March 1945, in connection with military operations against an energy of the United States. During the hazardous fighting near WALDHOLZBACH, GERMANY, Pfc BERKHOUSE, despite severe hostile fire, advanced far ahead of his comrades. From his precarious position, he courageously destroyed two enemy pillboxes, killed five of the hostile force, and contributed immeasurably in routing the enemy. Pfc BERKHOUSE's courage and aggressiveness reflect great credit upon himself and the armed forces of the United States. Entered military service from PENNSYLVANIA.

JAMES R. DUDLEY, 33652881, Pfc, Co G, 318th Infantry, United States Army. For gallantry in action in GERWANY on 10 February 1945, in connection with military operations against and enemy of the United States. At the Sauer River crossing, Pfc DUDLEY, a rifleman, observed his squad being harrassed by fire from a distant pillbox. With disregard for safety, he charged through the hostile concentration over 250 yards of hazardous terrain to boldly assault the position and capture the hostile troops. Pfc DUDLEY's outstanding courage and devotion exemplify the highest traditions of the armed forces of the United States. Entered military service from VIRGINIA.

JAMES F. GAEBELEIN, 35067650, Sgt, Hq Co 2d Bn, 317th Infantry, United States Army. For gallantry in action in GERMANY on 15 April 1945, in connection with military operations against an enemy of the United States. Near KASSEL, GERMANY, Sgt GAEBELEIN, disregarding the numerical superiority of the hostile force, opened fire on an enemy garrison. Moving forward, he captured 22 stunned prisoners. Other enemy soldiers observing his fair treatment surrendered, bringing the total to 425, thus eliminating a serious threat to the advancing troops. Sgt GAEBELEIN's courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from OHIO.

THOMAS G. HAWKINS, 39905385, Pfc, Co E, 318th Infantry, United States Army. For gallantry in action in FRANCE on 8 November 1944, in connection with military operations against an enemy of the United States. At the hazardous Seille River crossing, Pfc HAWKINS! company was temporarily delayed and subjected to severe machine gun and mortar fire. With disregard for safety, he exposed himself to the concentration, located the hostile guns, and destroyed the positions with grenades. Pfc HAWKINS! courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from UTAH.

WILFRED W. HERR, 38433443, Sgt (then Pfc), Co A, 319th Infantry, United States Army. For gallantry in action in FRANCE on 10 September 1944, in connection with military operations against an enemy of the United States. At LIVERDUN, FRANCE, intense fire from two hostile machine guns delayed Sgt HERR's company. With disregard for safety, he charged one emplacement under the deadly fire, captured the gun and killed the crew. Turning the captured gun on the other enemy position, he destroyed the second gun. Sgt HERD's courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from TEXAS.

EDWARD J. LASHWAY, 31467544, S Sgt (then Pfc), Co A, 317th Infantry, United States Army. For gallantry in action in GERMANY on 21 February 1945, in connection with military operations against an enemy of the United States. Near HALSDORF, GERMANY, S Sgt LASHWAY exposed himself to an intense hostile cross fire to locate enemy guns delaying his company. Then, displaying courage and outstanding leadership, he quickly deployed his platoon and led an attack, despite the danger, which destroyed the enemy installations. S Sgt LASHWAY's leadership and devotion to duty reflect great credit upon himself and the armed forces of the United States. Entered military service from MASSACHUSETTS.

WILLIAM H. MALONE, 34658064, Pfc, Med Det, 318th Infantry, United States Army. For gallantry in action in GERMANY on 20 March 1945, in connection with military operations against an enemy of the United States. At NEUSTADT, GERMANY, Pfc MALONE, with disregard for personal safety, subjected himself to intense hostile machine gun and sniper fire to evacuate a critically wounded comrade. Returning to the leading elements of the assault force, he again braved severe enemy fire to remove from an exposed position, three seriously wounded comrades. Pfc MALONE's courage and devotion to duty reflect great credit upon himself and the armed forces of the United States. Entered military service from SOUTH CAROLINA.

DANIEL W. McCARTHY, 34490042, S Sgt, Co H, 318th Infantry, United States Army. For gallantry in action in GERMANY on 15 March 1945, in connection with military operations against an enemy of the United States. While attempting to deliver supplies to embattled and surrounded comrades, S Sgt McCARTHY and his companions were subjected to hostile machine gun fire and were dispersed. With disregard for safety, he exposed himself to rescue a wounded comrade and then formed the men into a fighting unit to destroy the opposition and open the supply route. S Sgt McCARTHY's leadership and aggressiveness exemplify the highest traditions of the armed forces of the United States. Entered military service from TENNESSEE.

WILBUR K. MORRIS, 0381935, 1st Lt, Infantry, 317th Infantry, United States Army. For gallantry in action in GERMANY on 9 April 1945, in connection with military operations against an enemy of the United States. Lt MORRIS, a Rifle Platoon Leader, at BINDERSLEBEN, GERMANY, displayed outstanding leadership and gallantry in leading a successful attack on the town. Despite the fierce enemy resistance, he led his platoon in capturing an airfield, munitions dump, a hostile garrison, and 150 enemy troops. Lt MORRIS' courage and aggressiveness exemplify the highest traditions of the armed forces of the United States. Entered military service from OHIO.

GERALD V. MYERS, 37742327, Sgt, Co G, 317th Infantry, United States Army. For gallantry in action in GERMANY on 28 March 1945, in connection with military operations against an enemy of the United States. Deep in hostile territory, Sgt MYERS courageously charged and destroyed a hostile pillbox. Continuing with his voluntary patrol, he engaged a numerically superior force in a fierce fire fight, captured fifty-six prisoners, and obtained the enemy's defense plans for KASSEL, GERMANY, his company's objective. Sgt MYERS' initiative and aggressiveness exemplify the highest traditions of the armed forces of the United States. Entered military service from MISSOURI.
