I. AWARD OF SILVER STAR, POSTHUMOUSLY: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded, posthumously, to the following named personnel:

Charles O. Snyder, 32915840, Pvt, Inf, Army of the United States. For gallantry in action in Luxembourg on 27 January 1945, in connection with military operations against an enemy of the United States. On 27 January 1945, during the attack on Hosingen, Luxembourg, Pvt Snyder, acting as communication sergeant of an assaulting rifle company, carried a heavy radio through waist deep snow drifts and over rough terrain in order to maintain communication with the battalien. After a mortar concentration fell nearby, Pvt Snyder's radio would not operate. With utter disregard for his own personal safety, he crossed exposed terrain to borrow another radio. Advancing through heavy small arms fire with the leading elements of the company, Pvt Snyder was mortally wounded. His courage, determination, and loyal devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from New Jersey.

II. AWARD OF BRONZE STAR, POSTHUMOUSLY: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded, posthumously, to the following named personnel:

Irving Gutz, 32876556, Pfc, Inf, Army of the United States. For heroic achievement in Germany on 5 February 1945, in connection with military operations against an enemy of the United States. Previous attempts to cross the Sure River had been defeated by enemy action and the swift current. On 5 February 1945, Pfc Gutz, as a member of a reconnaissance patrol, accomplished this hazardous task. Continuing through Wallendorf, Germany, and into the Siegfried Line, they encountered, and after a sharp battle, routed an enemy patrol. After thoroughly reconnoitering the enemy territory and acquiring valuable information, Pfc Gutz was mortally wounded while attempting to recross the river under intense enemy machine gun fire. His courage, aggressiveness, and unselfish devotion to duty contributed greatly in accomplishing a vital intelligence mission and exemplify the highest traditions of the armed forces of the United States. Entered military service from New York.

Henry L. McCullough, 18008191, Sgt, Inf, Army of the United States. For heroic achievement in Germany on 5 February 1945, in connection with military operations against an enemy of the United States. Previous attempts to cross the Sure River had been defeated by enemy action and the swift surrent.
