I. AWARD OF PURPLE HEART (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Purple Heart previously awarded, a bronze Oak Leaf Cluster is awarded S Sgt Louis Parsons, 35312851, Inf, for wounds received as a result of enemy action in France on 26 November 1944.

II. AWARD OF PURPLE HEART (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Purple Heart previously awarded, a bronze Oak Leaf Cluster is awarded Pvt Claudie V. Kincaid, 38107504, Inf, for wounds received as a result of enemy action in Germany on 5 March 1945.

III. AWARD OF PURPLE HEART: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Purple Heart is awarded Pvt James R. Knott, 33566349, CAC, for wounds received as a result of enemy action in Luxembourg on 18 February 1945.

IV. AWARD OF PURPLE HEART: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Purple Heart is awarded the following named personnel for wounds received as a result of enemy action in Germany on dates indicated:


