I. AWARD OF SILVER STAR: By direction of the President, under the provisions of Army Regulations 600 45, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named personnel:

- For gallantry in action in Luxembourg on 23 and 25 December 1944, in connection with military operations against an enemy of the United States. On 23 December 1944, the Germans launched a tank-infantry counterattack on Heiderscheid, Luxembourg. Capt Chamberlin, commander of a rifle company, organized rocket launcher teams and by placing them in advantageous positions was able to repulse the enemy. Two days later on 25 December 1944, at Ringel, Luxembourg, he again distinguished himself by riding a tank into battle and from this exposed position directed accurate and effective fire on the enemy. Capt Chamberlin's courage, aggressiveness, and skill are in keeping with the highest traditions of the armed forces of the United States. Entered military service from California.
- Benicourt, France, Pfc DeHart, an automatic rifleman, advanced with his squad which was protecting the flank of an assaulting company. Intense machine gun fire from a farm house temporarily delayed the attack. Pfc DeHart and his assistant, with utter disregard for personal safety, moved to a position from which they effectively neutralized the enemy machine gun fire. Although both were wounded Pfc DeHart continued firing for four hours and on being relieved carried his seriously wounded assistant to safety. Pfc DeHart's courage, perseverance, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Harry W. Dressler, 33253745, Tec 5, CE, Army of the United States. For gallantry in action in Luxembourg on 7 February 1945, in connection with military operations against an enemy of the United States. On 7 February 1945, the combat engineer squad in which Tec 5 Dressler operated a mine detector was removing mines from the road near Bettel, Luxembourg. When the squad approached to lift the mines it was subjected to direct fire from forts in the Siegfried Line and was forced to take cover. Disregarding the danger and the warning of his squad leader, he continued on his mission and by his example encouraged the rest of the squad to resume operation. Even though a shell

detonated a large collection of mines nearby he continued his work and led the squad forward to complete clearing the road to allow the infantry to pass. Tec 5 Dressfer's courage, leadership, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

GARLAND D. GODBY, Ol285576, Capt, Inf, Army of the United States. For gallantry in action in Luxembourg on 25 December 1944, in connection with military operations against an enemy of the United States. After Ringel, Luxembourg, was liberated on 25 December 1944, the enemy counterattacked with a numerically superior force. Capt Godby, commanding an infantry company, personally placed his men in position to repel the enemy and then manned a .50 caliber machine gun in spite of severe small arms fire in the area. Observing an enemy threat against which a tank destroyer could be best used, Capt Godby turned the machine gun over to an enlisted man and, running through heavy mortar fire, directed a nearby tank destroyer in driving back and inflicting heavy losses on the enemy. Capt Godby's courage, aggressiveness, and devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Kentucky.

Peter Jaye, 32024247, S Sgt, MD, Army of the United States. For gallantry in action in Luxembourg on 8, 9, and 10 February 1945, in connection with military operations against an enemy of the United States. On 8, 9, and 10 February 1945, while the bridgehead from Luxembourg across the Sauer River into the Siegfried Line was being strongly contested, S Sgt Jaye ably operated a temporary aid station to care for wounded evacuated across the river by boat. Although the aid station was hit by enemy artillery several times, under the supervision of S Sgt Jaye, over two hundred and fifty patients received their initial treatment and were evacuated under the cover of darkness without the loss of a single life. S Sgt Jaye's courage, skill, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from New York.

Thomas M. Pullin, 35385832, 1st Sgt, FA, Army of the United States. For gallantry in action in Germany on 12 February 1945, in connection with military operations against an enemy of the United States. During preparation for an attack near Biesdorf, Germany, on 12 February 1945, 1st Sgt Pullin, serving as an artillery forward observer, advanced over exposed terrain to a position from which he calculated data for the initial artillery barrage. In spite of the continuous fire directed at him he remained in position until his mission was completed. Just prior to the infantry assault he again advanced to adjust fire and, although his radio was destroyed by enemy shelling, he relayed his adjustments through a rifle company radio net. He continued his operations in this exposed position until he was seriously wounded. His courage, initiative, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Ohio.

Alexander E. Russell, 39621598, S Sgt, Inf, Army of the United States. For gallantry in action in France on 9 November 1944, in connection with military operations against an enemy of the United States. On 9 November 1944, near Eply, France, S Sgt Russell, while assaulting entrenched enemy positions,

was wounded by a mortar shell which also destroyed the tripod of his light machine gun. Disregarding his wounds and the intense enemy fire, S Sgt Russell continued the attack holding the machine gun at his hip with the cartridge belt looped over his shoulder. The fire power of his machine gun materially aided in taking the objective, after which he permitted his wounds to be dressed. S Sgt Russell's courage and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Montana.

Edwin C. Schultz, 36889250, Sgt, Inf, Army of the United States. For gallantry in action in Germany on 13 February 1945, in connection with military operations against an enemy of the United States. In an infantry attack near Biesdorf, Germany, on 13 February 1945, Sgt Schultz, a squad leader, observed that the company advance had been limited by an enemy machine gun in a wooded area. Armed with a light machine gun he advanced three hundred yards on an encircling movement and approached the enemy from the rear. At fifty yards he opened fire, killing the entire crew and protecting riflemen. Sgt Schultz's courage, initiative, and devotion to duty permitted the company to advance without casualties and is in keeping with the highest traditions of the armed forces of the United States. Entered military service from Michigan.

Howard T. Storm, 35460894, Sgt, Inf, Army of the United States. For gallantry in action in France and Luxembourg on 11 November 1944, and 23 January 1945, in connection with military operations against an enemy of the United States. On two occasions Sgt Storm has distinguished himself by gallantry in action with the cannon company of which he was a member. On 11 November 1944, near Bechy, France, while the howitzers were being emplaced, enemy artillery scored a direct hit on an ammunition truck. Disregarding the danger of fire and exploding shells Sgt (then Pvt) Storm carried all the wounded from the vicinity of the burning truck. On 23 January 1945, when a driver of a prime mover had been wounded by a mine, Sgt Storm carried him through a heavily mined area to safety. Sgt Storm's courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Ohio.

FRANK T. ZACHMAN, Ol184006, 2d Lt, FA, Army of the United States. For gallantry in action in Luxembourg on 8 January 1945, in connection with military operations against an enemy of the United States. On 8 January 1945, during an attempt by the enemy to retake the town of Dahl, Luxembourg, which had been recently liberated, Lt Zachman voluntarily advanced over four hundred yards of open terrain despite withering machine gun fire to his artillery observation post. From this location he adjusted emergency concentrations of artillery to within fifty yards of his own position, contributing immeasurably to the rout of the enemy. Lt Zachman's courage, initiative, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Kansas.

II. AWARD OF BRONZE STAR (OAK LEAF CLUSTER): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, in addition to the Bronze Star Medal previously awarded, a bronze Oak Leaf Cluster is awarded the following named personnel:

Roy C. Helzer, 39528116, T Sgt, Inf, Army of the United States. For

heroic service in Germany during the period 10 - 12 February 1945, in connection with military operations against an enemy of the United States. During the period 10 - 12 February 1945, T Sgt Helzer distinguished himself in performing his duties as platoon sergeant in a courageous manner. He has consistently demonstrated coolness under fire and outstanding ability as a leader. On one occasion, when the platoon became separated after crossing a river at night, T Sgt Helzer, acting as platoon leader, successfully regrouped his men and led them forward under intense enemy fire to seize the assigned objective. His bravery, resourcefulness, and unselfish devotion to duty exemplify the finest traditions of the armed forces of the United States. Entered military service from California.

III. AWARD OF BRONZE STAR: 3y direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

Manuel N. Barreda, 39462247, Pfc, MD, Army of the United States. For heroic achievement in Germany on 9 February 1945, in connection with military operations against an enemy of the United States. During the assault for the initial bridgehead across the Sauer River into the Siegfried Line on 9 February 1945, Pfc Barreda, an officer, and another enlisted man volunteered to establish an advance aid station to care for the wounded. Crossing the river in a boat, they worked continuously for thirty six hours despite heavy shell fire to sustain life in the wounded until they could be ferried across the river. Pfc Barreda's courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Washington.

ABRAHAM J. BOTNICK, Ol172386, 1st Lt, FA, Army of the United States. For meritorious service in France, Luxembourg, and Germany during the period 6 August 1944, to 20 February 1945, in connection with military operations against an enemy of the United States. Entered military service from New York.

Buford D. Bullman, 20405716, T Sgt, Inf, Army of the United States. For heroic achievement in Luxembourg on 8 February 1945, in connection with military operations against an enemy of the United States. On 8 February 1945, T Sgt Bullman was serving as ammunition and pioneer platoon leader of an infantry battalion assaulting enemy positions on the far side of a river. Attempts to construct a bridge were unsuccessful due to the strong current and heavy hostile fire. T Sgt Bullman, disregarding personal safety, organized carrying parties and repeatedly crossed the river under fire with boatloads of vitally needed ammunition. The leadership, courage, and unselfish devotion to duty displayed by T Sgt Bullman are in keeping with the finest traditions of the armed forces of the United States. Entered military service from South Carolina.

MELVIN CAPLAN, W2132011, W0JG, Army of the United States. For meritorious service in France and Luxembourg during the period 8 August 1944, to 20 February 1945, in connection with military operations against an enemy of the United States. Entered military service from Pennsylvania.

Arby L. Johnson, 6259848, 1st Sgt FA, United States Army. For meritorious service in France and Luxembourg during the period 6 August 1944, to 15 February 1945, in connection with military operations against an enemy of the United States. Entered military service from Oklaboma.

Kenneth A. King, 31339121, Pfc, MD, Army of the United States. For heroic achievement in Germany on 11 February 1945, in connection with military operations against an enemy of the United States. On 11 February 1945, Pfc King, an aid man, was engaged in evacuating wounded across the Sauer River and through areas heavily mined. As the heavy artillery and mortar fire greatly hindered the aid men, Pfc King, seeking a quicker method of evacuation, located an abandoned one quarter ton truck which he drove for over forty eight hours, evacuating many wounded over roads yet uncleared of mines. Pfc King's courage, initiative, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Vermont.

EDMUND R. KINNE, 0475126, Capt (then 1st Lt), MD, Army of the United States. For heroic achievement in Germany on 9 February 1945, in connection with military operations against an enemy of the United States. During the assault for the initial bridgehead across the Sauer River into the Siegfried Line on 9 February 1945, Capt Kinne and two enlisted men volunteered to establish an advance aid station to care for the wounded. Crossing the river in a boat they worked continuously for thirty six hours despite heavy shell fire to sustain life in the wounded until they could be ferried across the river. While performing these duties he was wounded by shell fragments. Capt Kinne's courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from New York.

Wilho M. Oikarinen, 36185628, Pfc, Inf, Army of the United States.

For heroic service in France and Luxembourg during the period 6 August 1944, to 19 February 1945, in connection with military operations against an enemy of the United States. During the period 6 August 1944, to 19 February 1945, Pfc Oikarinen distinguished himself in performing his duties as messenger in a courageous manner. Working with a forward artillery observer, he has, on numerous occasions, with utter disregard for his own safety, made repeated trips over terrain exposed to heavy enemy artillery and mortar fire to deliver important messages and bring up vitally needed equipment and supplies. The bravery, determination, and constant devotion to duty displayed by Pfc Oikarinen exemplify the finest traditions of the armed forces of the United

Despite being in an exposed position and surrounded by enemy troops, Capt Park organized a perimeter defense which held against strong enemy opposition. By calling for artillery fire he was able to inflict heavy damage on the enemy and to hold out until reinforcements reached him. Capt Park's courage, perseverance, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Kentucky.

Joseph J. Pelle, 32873343, Tec 5, FA, Army of the United States. For heroic service in France and Luxembourg during the period 1 October 1944, to 15 February 1945, in connection with military operations against an enemy of the United States. During the period 1 October 1944, to 15 February 1945, Tec 5 Pelle distinguished himself in performing his duties as radio operator in a courageous manner. Serving with a forward observer team, he has operated his radio, frequently under intense enemy fire, for long periods of time without relief. By his tireless efforts, outstanding efficiency, and utter disregard for his own safety he has maintained continuous radio communication for the effective direction of artillery fire. The bravery, technical skill, and loyal devotion to duty displayed by Tec 5 Pelle are commensurate with the finest traditions of the armed forces of the United States.
