I Will R. Case, Jr, 35463095, T Sgt, Inf, Army of the United States. For heroic service in France, Luxembourg, and Germany during the period 7 August 1944, to 14 January 1945, in connection with military operations against an enemy of the United States. During the period 7 August 1944, to 14 January 1945, T Sgt Case has performed his duties as platoon sergeant of a rifle company in a superior manner. His initiative, leadership, and tactical knowledge have contributed immeasurably to the success of his company in its drive through France, Luxembourg, and Germany and are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Kentucky.

Robert P. Coughlin, 33594154, T Sgt (then Sgt), Inf, Army of the United States. For heroic achievement in France on 13 November 1944, in connection with military operations against an enemy of the United States. While leading his machine gun squad against a well defended enemy position near Many, France, on 13 November 1944, T Sgt Coughlin was painfully wounded by a shell fragment. Refusing medical aid he continued to lead his men until the objective was attained, the position consolidated, and all of his squad accounted for. T Sgt Coughlin's courage, aggressiveness, and sincere devotion to duty are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Andrew W. Hilburn, 38113542, Pfc, Inf, Army of the United States. For heroic achievement in Luxembourg on 11 February 1945, in connection with military operations against an enemy of the United States. On 11 February 1945, near Dillingen, Luxembourg, Pfc Hilburn and a companion, while waiting to cross the Sauer River by boat, were forced by a heavy mortar concentration to take cover on the river bank. A boat returning from the other side of the river capsized while the mortar rounds were falling about these two men. Disregarding personal danger, Pfc Hilburn and his comrade left their comparative safety and rescued two men who could not swim. Pfc Hilburn's courage, initiative, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Texas.

Osa E. Horton, 38190323, Pfc, MD, Army of the United States. For heroic achievement in Germany on 9 February 1945, in connection with military operations against an enemy of the United States. During the initial bridge-head across the Sauer River into the __gfried Line on 9 February 1945, Pfc Horton, an officer, and another enlis ed man volunteered to establish an advance aid station to care for the many wounded. Crossing the river in a boat they worked continuously for thirty six hours despite heavy shell fire to sustain life in the wounded until they could be ferried across the river. Pfc Horton's courage and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Oklahoma.

Philip L. Llewellyn, 33323480, T Sgt, Inf, Army of the United States. For heroic achievement in Germany on 20 February 1945, in connection with military operations against an enemy of the United States. Near Biesdorf, Germany, on 20 February 1945, T Sgt Llewellyn, an anti-tank platoon sergeant, realizing that enemy artillery shells falling about his position were from direct fire weapons, advanced alone through severe sniper and machine gun fire to located the enemy artillery positions. Making a thorough reconnaissance he located enemy tanks and after returning to friendly lines he aided in adjusting fire which drove the tanks from their positions. T Sgt Llewellyn's courage, initiative, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

Raymond J. Radke, 37572045, T Sgt (then S Sgt), Inf, Army of the United States. For heroic achievement in France on 12 November 1944, in connection with military operations against an enemy of the United States. On 12 November 1944, the plateon in which T Sgt Radke served as platoon sergeant was preparing a defensive position to repel an enemy attack. Recognizing that a draw on the flank of his sector would be a logical approach for the enemy, T Sgt Radke and two soldiers armed with automatic rifles dug in to protect this area. As anticipated, the enemy advanced into the draw where the accurate fire of T Sgt Radke and his comrades inflicted heavy losses on them and denied this approach to repeated German thrusts. T Sgt Radke's courage, farsightedness, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Minnesota.

Ben H. Renwick, 14124186, S Sgt, Inf, Army of the United States. For heroic achievement in Luxembourg on 23 December 1944, in connection with military operations against an enemy of the United States. During the attack on Tadler, Luxembourg, on 23 December 1944, S Sgt Renwick, a section sergeant, was forced to move his platoon across open terrain on which enemy mortar and artillery fire was falling in order to support the rifle troops. With utter disregard for his own safety, S Sgt Renwick moved one section to an exposed position and fired such excellent neutralizing fire on the enemy that the advancing section reached their objective. After the move was completed S Sgt Renwick moved the remaining section forward without a casualty. S Sgt Renwick's courage, initiative, and leadership exemplify the highest traditions of the armed forces of the United States. Entered military service from South Carolina.

Herbert W. Sheley, 35878321, Pvt, Inf, Army of the United States. For heroic achievement in France on 26 September 1944, in connection with military operations against an exemy of the United States. On 26 September 1944,

during the attack on Moivron, France, Pvt Sheley observed an enemy anti-tank gun, supported by riflemen, firing on friendly tanks. Realizing the seriousness of this threat, Pvt Sheley, with utter disregard for his own safety, assaulted the enemy position and neutralized its fire until wounded by a sniper. Pvt Sheley's courage and aggressiveness contributed materially to the success of the attack and is in keeping with the highest traditions of the armed forces of the United States. Entered military service from Ohio.

MILBUR W. WEST, Oll78386, 2d Lt, FA, Army of the United States. For heroic achievement in Germany on & February 1945, in connection with military operations against an enemy of the United States. On 8 February 1945, Lt West, an artillery observer, was attached to an infantry company whose mission was the assault of Siegfried Line positions near Wallendorf, Germany. Severe mortar and artillery fire temporarily delayed the assault and wounded many men who were left in exposed positions. In order to make possible their evacuation and further deployment of the company, Lt West, with utter disregard for his own personal safety, crawled to a position from which he adjusted smoke shells for two hours to screen the operations. Lt West's courage, initiative, and devotion to duty exemplify the highest traditions of the armed forces of the United States. Entered military service from Michigan.

Lt Silva's resourcefulness and devotion to duty are in keeping with the finest traditions of the armed forces of the United States. Entered military service from Massachusetts.

Julius A. Andres, 12018381, 1st Sgt, Inf, Army of the United States. Lawrence H. Bondurant, 37141361, S Sgt, FA, Army of the United States. For heroic achievement in Luxembourg on 26 December 1944, in connection with military operations against an enemy of the United States. Near Kehmen, Luxembourg, on 26 December 1944, heavy enemy artillery wounded the platoon leader of a tank platoon supporting an infantry attack. VI. AWARD OF BRONZE STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named personnel:

A Charles E. Carson, 34002459, 1st Sgt, Inf, Army of the United States. For heroic achievement in France on 16 November 1944, in connection with military operations against an enemy of the United States. During the attack on Adelange, France, on 16 November 1944, 1st Sgt Carson, while moving his company headquarters behind the attacking echelon, observed that there was an inadequate number of litter squads to evacuate the wounded riflemen. On his own initiative he organized and directed a system of evacuation which removed all American and a few enemy casualties from the battlefield. 1st Sgt Carson's leadership, initiative, and devotion to duty are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Georgia.
