After crossing a river the patrol encountered machine gun fire and enemy anti-personnel mines. One of the mines exploded severely wounding 2d Lt Rigg and one member of his patrol. Despite severe wounds in the face, head, and shoulder, 2d Lt Rigg picked up the wounded member of his patrol and while under enemy small arms fire carried him to safety. The bravery, courage, and devotion to duty displayed by 2d Lt Rigg are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Montana.

CHARLES D. SAMMONS, 0412642, Maj, Inf.(Armd), Army of the United States. For meritorious achievement in France during the period 6 August 1944, to 8 November 1944, in connection with military operations against an enemy of the United States. Entered military service from Pennsylvania.

S Sgt Sicking, accompanied by another enlisted man, moved a light machine gun forward of the platoon's position and to the flank, located the enemy machine gun position by drawing its fire and returned fire on the machine gun, destroying it. This was accomplished while under intense enemy machine gun fire. The courage, resourcefulness, and devotion to duty displayed by S Sgt Sicking exemplify the finest traditions of the armed forces of the United States. Entered military service from Indiana.

Jerry Staley, 35698078, Pvt, Inf, Army of the United States. For heroic achievement in France on 8 October 1944, in connection with military operations against an enemy of the United States. On 8 October 1944, during an attack on the enemy, one of the platoons of Pvt Staley's company was temporarily stopped by intense enemy machine gun fire. Pvt Staley came upon an abandoned American machine gun that had been put out of action, took it apart, cleaned it, and moved it to an effective position whereupon he proceeded to destroy an enemy machine gun nest, several automatic weapons, and captured eight prisoners, enabling the platoons to move forward and successfully accomplish their mission. The outstanding courage, resourcefulness, and sincere devotion to duty displayed by Pvt Staley are in keeping with the highest traditions of the armed forces of the United States. Entered military service from Kentucky.

James E. Sturgill, 33214384, Sgt, Inf, Army of the United States. For meritorious service in France on 5 October 1944, in connection with military operations against an enemy of the United States. Entered military service from Virginia.

Pfc Robinette, with total disregard for his own safety and displaying cocl courage, crawled out onto the battlefield in the face of intense enemy fire and dragged the wounded man to safety. The courage and sincere devotion to duty displayed by Pfc Robinette, are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Kentucky.

Displaying cool courage and total disregard for his own safety, S Sgt Burden moved out in front of the enemy and with his Browning Automatic Rifle personally assaulted the enemy position, reducing its fire and enabling his platoon to move forward and successfully take the position. The courage, resourcefulness, and devotion to duty displayed by S Sgt Burden reflects creditably upon himself and the armed forces of the United States. Entered military service from Pennsylvania.

LLOYD C. COLE, 01174536, Capt, FA, Army of the United States. For meritorious achievement in France during the period 24 October 1944, to 8 November 1944, in connection with military operations against an enemy of the United States. Entered military service from Tennessee.

Florian F. Mikulski, 33067291, Pfc, CE, Army of the United States. For heroic service in France on 4 September 1944, in connection with military operations against an enemy of the United States. On 4 September 1944, Pfc Mikulski was a member of a platoon of engineers engaged in ferrying infantry troops across a river to the enemy held side. The mission was extremely hazardous as enemy observation was excellent and enemy artillery, morter, and machine gum fire was heavily concentrated upon the river. The first wave of infantry crossed safely but were temporarily halted by a heavy artillery barrage. Realizing the situation and knowing our troops were outnumbered, Pfc Mikulski volunteered to ferry reinforcements across the river. He was a conspicuous target in the bright mounlight but by altering his course and dodging heavy enemy fire he safely reached the enemy shore, thus enabling the infantry troops to successfully accomplish the mission. The courage, fearlessness, and devotion to duty displayed by Pfc Mikulski are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Maryland.

WILLIAM B. MILLER, 01018307, 1st Lt, Inf (Armd), Army of the United States. For meritorious service in France during the period 8 October 1944, to 9 November 1944, in connection with military operations against an enemy of the United States. Entered military service from West Virginia.

DALE G. ROBERTS, Ol011766, Capt, Cav (Armd), Army of the United States. For meritorious service in France during the period 6 August 1944, to 9 November 1944, in connection with military operations against an enemy of the United States. Entered military service from Minnesota.

Pvt Rzasa crawled to his wounded comrade, who was lying in an exposed posttion, and in full view of the enemy carried him out of the zone of enemy fire to a place of safety. The courage and devotion to duty displayed by Pvt Rzasa exemplify the finest traditions of the armed forces of the United States. Entered military service from Pennsylvania.

VI. AWARD OF BRONZE STAR (MISSING IN ACTION): By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named Enlisted Man (Missing in Action):

FREDERICK T. LECHER, 0367769, 1st Lt, Inf, Army of the United States: For heroic service in France on 18 September 1944, in connection with military operations against an enemy of the United States. On 18 September 1944, the Regimental Command Post to which 1st Lt Lecher was attached was subjected to an enemy attack. A part of the high ground in the immediate vicinity was held by friendly troops who were unacquainted with the location of the command post and were also subjecting it to their fire. Alone, 1st Lt Lecher set out to acquaint the friendly troops with the situation and location of the Regimental Command Post. This necessitated his traveling for some distance under direct fire of both friendly and enemy gums. 1st Lt Lecher accomplished his mission and saved the Regimental Command Post from further fire from friendly gums. The outstanding courage, initiative, and incere devotion to duty displayed by 1st Lt Lecher reflects great credit upon himself and the armed forces of the United States. Entered military service from New Jersey.

VII. AWARD OF BRONZE STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named Officer and Enlisted Men:

VINCENT F. HART, 0461553, Capt, Ch Corps, Army of the United States. For heroic scrvice in France on 20 august 1944, in connection with military operations against an enemy of the United States. On 20 August 1944, Chaplain Hart, upon being notified that four wounded comrades were being concealed and cared for in the vicinity of the front lines, voluntarily secured an ambulance and proceeded in company with four enlisted men through the front lines under heavy artillery fire and successfully evacuated the four wounded men to safety.
