IV. AWARD OF SILVER STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Silver Star Medal is awarded the following named Officer:

GEORGE E. SCHULD 01325619, 2d Lt, Inf, Army of the United States. For gallantry in action in France on 8 October 1944, in connection with military operations against an enemy of the United States. On 8 October 1944, Lt Schuld was in command of a heavy weapons platoon in support of an infantry company engaged in an attack upon an extremely well camouflaged and heavily fortified enemy position. Despite the raking enemy machine gun fire, Lt Schuld, accompanied by a messenger, courageously advanced and successfully assauhted the enemy pillbox thereby permitting the uninterrupted progress of the infantry company and resulting in the capture of five Germans and two enemy machine guns. His personal bravery, resourcefulness, and sincere devotion to duty are commensurate with the finest ideals of the armed forces of the United States. Entered military service from Connecticut.

V. AWARD OF BRONZE STAR: By direction of the President, under the provisions of Army Regulations 600-45, dated 22 September 1943, as amended, the Bronze Star Medal is awarded the following named Enlisted Men:

Robert J. Miles, 35461349, T Sgt, Inf, Army of the United States. For meritorious achievement in France on 26 November 1944, in connection with military operations against an enemy of the United States. On 26 November 1944, T Sgt Miles assumed command of a rifle platoon when his platoon leader was wounded by the enemy during the defense of a strategically important hill. T Sgt Miles led and encouraged his men throughout the entire afternoon and evening and successfully repulsed the enemy. The outstanding leadership, personal courage, and devotion to duty displayed by T Sgt Miles are commensurate with the highest traditions of the armed forces of the United States. Entered military service from Ohio.

Robert J. Runyon, 36250991, Pfc, CE, Army of the United States. For heroic service in France on 6 October 1944, in connection with military operations against an enemy of the United States. On 6 October 1944, Pfc Runyon assumed command of the remaining members of his squad after an explosion of mines had killed his squad leader and seriously wounded his plateon commander and assistant squad leader. Pfc Runyon cooly proceeded to complete the mission assigned the squad of the removal of anti-personnel mines from this dangerous vicinity. Later Pfc Runyon was engaged with his plateon in a river crossing near Clemery, France. After having ferried a number of infantry across the river, he temporarily lost control of his boat and was carried downstream into an enemy field of fire. Alone and unaided, Pfc Runyon successfully recovered control of his boat, returning through heavy enemy fire to resume his mission. His outstanding courage, initiative, and devotion to duty reflect great credit upon himself and the armed forces of the United States. Entered military service from Wisconsin.

Orville L. Smith, 35408191, Sgt, Inf, Army of the United States. For meritorious service in France during the period 8 November 1944, to 8 December 1944, in connection with military operations against an enemy of the United States. Entered military service from Ohio.

For heroic achievement in France during the period 21 - 22 November 1944, in connection with military operations against an enemy of the United States. During the period 21 - 22 November 1944, Pvt Spellman was acting as radio operator with an artillery forward observer with a front line infantry company which was surrounded and isolated from friendly forces.
